Sir,

With due respect, I Smt. Muskan Mahato @ Ray W/o Sri Guddu Mahato resident of Patiram Jote, P.O & P.S - Matigara, District - Darjeeling, presently residing at Ganganagar, Near Rani Sati Mandir, SMC Ward No - 5, Siliguri, P.O & P.S - Siliguri, Distrit - Darjeeling would like to inform you that on 1 - 2 - 2019 my marriage was solemnized with Guddu Mahato S/o Sri Gour Shankar Mahato resident of Patiram Jote, P.O & P.S - Matigara, District - Darjeeling according to Hindu rites and customs at my parental house. At the time of marriage, my parents have fulfilled all the illegal demands of dowry by giving a sum of Rs. 50,000/- cash, one Motorcycle, Gold ornaments weighing about 20 grams, Silver ornaments, utensils clothing and gift items, bed and bedding, etc. After marriage I was being brought by my husband and other - in laws at my matrimonial house at patiram and started my conjugal life at my matrimonial house. Soon after marriage my father in law Sri Gouri Shankar Mahato, Mother in Law Smt. Mina Mahato and Sister in Law Radha Mahato have starter claiming that I am not fit for their son and brother Sri Guddu Mahato and have started claiming that if the marriage of Guddu Mahato was solemnized with some other girl then they must got more dowry and have started inducing my husband to demand money from my parents. Though the above named persons are well aware that the financial condition of my parents is not so sound which can fulfil their demand inspite of that my parents have helped them financially off and on as per their demand but the lust of demand of money from the end of my husband and other in laws was not ended and on the issue of demand of money and articles when I have denied for the same, the above named persons have started assaulting me mentally and physically and several time I was ousted from my matrimonial house and on every ousting, meetings used to took place and with intention to lead my happy matrimonial house I used to return back to my matrimonial house. Be it mention here that several meeting and negotiations took place against the tortures of my husband and inlaws. On 16 - 7 - 2019 I have informed the matter to Pradhan, Matigara Gram Panchyat. Due to continuous torture from the end of my husband and in-laws, even I was egger for mutual divorce but due to continuous threat from the end of my husband the said negotiation for mutual divorce also failed and fresh negotiation took place in between me and my husband and accordingly an agreement was executed on 26 - 3 - 2021 and after the said negotiation I again shifted to my matrimonial house. In the mean time I became pregnant, and on 11 - 12 - 2022 I delivered a female child namely Advika Mahato at Siliguri Sadar Hospital and I was brought by my parents at my parental house from the hospital and after three months i.e. 10 - 3 - 2022 I was being brought by my husband at my matrimonial house. During my stay with my child, my husband and other in-laws have lifted their hand to maintain me and my child on the pleading that they are not happy with the female child and they have no money to bear the expenses.

Yesterday i.e. 24 - 12 - 2023 at about 5.30 p.m my husband came in drunken condition and has started querrling with his mother Smt. Mina Mahato and when I have tried to restrain my husband, he without any issue has started assaulting me with fist and blows and when I have raised my objection , my father in law and Sister in law have started inducing my husband and mother in law to assault me and oust me from the house and upon the said inducement, I have been ousted with my baby from my matrimonial house in injured condition and finding no other alternative, I have shifted to my parental house and I have been treated at Siliguri Sadar Hospital. Be it mention here that from the day of my marriage, my entire expenses of clothing and person expenses is being bear by my parents. Inpiste of inhuman mental and physical tortures, I have tried my level best to lead my conjugal life but my all efforts were in vain.

So requesting you to investigate the matter and take necessary legal action against the above named person for the interest of justice.
