Respected Sir/Madam,

I am Satyendeo Prasad Rastogi, son of Late Dharam Nath Prasad Rastogi, resident of Bhanu Bhakta Sarani, Gurung Basti, Pradhan Nagar, Siliguri 734003, Ward No. 3 of S. M. C., P.O. & P.S. Pradhan Nagar, District Darjeeling. I am writing to bring to your attention a distressing incident that occurred on 25<sup>th</sup> December 2023.

On the above mentioned date, about 9 am, I was subjected to a brutal assault and battery at the Stall No. GC-14, Trade Mark- DNP, Siliguri Regulated Market, Mallaguri, Siliguri - 3. The perpetrators include Janak Rastogi, Chotelal Rastogi, Rohit Rastogi, Mohit Rastogi, Ankit Rastogi, Anikat Rastogi, Nabin Sah, Pashupati Prasad Rastogi, Pradip Kumar Rastogi, Rajesh Rastogi, and Dilip Rastogi. I managed to escape the attack with the help of locals and subsequently sought emergency treatment at Siliguri District Hospital, Siliguri. Medical Slip enclosed herewith.

I am seeking your urgent intervention in this matter and kindly request you to initiate necessary action against the individuals involved. I hereby formally request the filing of a First Information Report (FIR) to ensure a thorough investigation into this violent incident.
