Sir,

In producing herewith two (02) arrested accused persons namely (i) Abdus Samad (M/28), S/O- Afrajul SK of Mozampur PS, Kaliachak, Dist. Malda and (ii) Ekramul SK (M/38), S/O- Lt. Manzur SK of Mozampur, Mominpara, PS, Kaliachak, Dist. Malda (not verified) along with the following articles under seizure as per seizure list;

- i) One (01) Mahindra Scorpio vlx vehicle having number plate, WB 58 T/1501,
- ii) One transparent pouch containing 358.070 grams of brown sugar, Contained in a black colour plastic carrybag and marked as "Exhibit- A",
- iii) Two(02) mobile phone of them one is "One Plus" having IMEI No-868660060298132/868660060298124 and other is "Nothing" phone having IMEI No-350778863125644/19 ; 350778863125651/19.

I, SI Biplab Sen, S/O- Kshitish Chandra Sen of Siliguri Police Station, Siliguri Police Commissionerate, do here by lodge this written complaint against above noted two (02) arrested accused persons namely Abdus Samad and Ekramul SK to the effect that today on 27.12.2023 at about 14:25 hrs I received a specific source input that two persons in a Scorpio vehicle having number plate, WB 58 T/1501 are stationed at New Milanpally, Sukanta Sarani under PS- Siliguri and possessing huge quantity of brown Sugar for selling the same to their designed customers for their wrongful gain. The matter was diarized vide Siliguri PS GDE No. 1471 Dt. 27.12.2023. Accordingly, I informed the matter to the Inspector-in-Charge, Siliguri Police Station in writing. Subsequently, as per his kind direction myself along with ASI Subir Sen, ASI Debasish Das all of Siliguri PS and along with investigation kit left for New Milanpally by govt. vehicle to verify the veracity of the information. This refers Siliguri PS GDE No. 1472 Dt. 27.12.2023 and Siliguri PS MCC No. 259/2023 Dt. 27.12.2023. On way I contact ASI Srijit Paul who was performing k-21 Van to accompany us to work out the information.

Under this circumstance any search warrant or authorization cannot be obtained without affording opportunity for the concealment of evidence or facility for the escape of the offender.

On way to New Milanpally, I contacted two persons namely (i) Md. Azzad (M/38), S/O- Md. Mehebab Ali of Tumbajote, P.O+PS- Matigara, Dist- Darjeeling and (ii) Parimal Sarkar (M/41) S/O Brajen Sarkar of Tumbajote, P.O+PS- Matigara, Dist- Darjeeling and make them aware of the information in hand and requested them to act as witness, if any search and seizure would be made necessary upon which they agreed.

Thereafter we along with the independent witnesses reached at New Milanpally, Sukanta Sarani, at 15:15 hrs and being pointed by my source detained the above noted vehicle having number plate WB 58 T/1501 inside which the above noted two accused persons namely Abdus Samad and Ekramul SK were found sitting inside the vehicle. Abdus Samad was sitting at driver's seat & Ekramul SK was sitting beside the driver. Thereafter, we disclosed our identity and the information in hand and stated them that they will be searched in person for the purpose. At this, they after disclosing their identity as noted above admitted that they have illegally possessed brown sugar in their possession for selling the same to their designed customers as per requirement. I then gave them option in writing whether they wanted to be searched in presence of Executive Magistrate or by any Gazetted Officer. Then they agreed to be searched in presence of any one of the above. I also offered the independent witnesses and the accused persons to search our Police Party as per provisions but, they did not search the police party. Accordingly, I informed the matter to I/C Siliguri PS and as per his kind order I informed to

Sri Gyalsen Lepcha, ACP, Siliguri Police Commissionerate detailed for acting as Special Executive Magistrate of SPC for the day, regarding the interception of the accused persons suspected to be possessed Brown Sugar and requested him to come at New Milanpally, Sukanta Sarani to remain present and to supervise the search and seizure. Accordingly at 16:45 hrs Sri Gyalsen Lepcha, ACP, SPC arrived at the spot as Special Executive Magistrate, SPC and in presence of two independent public witnesses I searched the detained persons as well as the vehicle having number plate WB 58 T/1501 following all formalities keeping their decency and recovered the above noted articles from the exclusive conscious and joint possession of Abdus Samad and Ekramul SK. On demand in presence of Sri Gyalsen Lepcha, ACP, SPC acting as Special Executive Magistrate, SPC the detained persons namely Abdus Samad and Ekramul SK failed to produce any valid document in support of possessing of the brown sugar.

Thereafter, I weighted the recovered packet with the weighing instrument and found total 358.070 grams of said to be brown sugar in the transparent packet which was recovered from a black colour plastic carrybag under the conscious and joint possession of accused persons namely Abdus Samad and Ekramul SK and marked as "Exhibit- A". I also labeled and sealed all the articles in presence of Sri Gyalsen Lepcha, ACP, SPC acting as Special Executive Magistrate, SPC and independent witnesses and accused persons.

Then, I seized the above noted articles at spot under proper seizure list and labeled duly signed by the above noted witnesses and the Special Executive Magistrate, SPC and acknowledged by the accused persons. The whole process of seizure was made in between 16.55 hrs to 17.25 hrs.

Being further asked the apprehend persons namely Abdus Samad and Ekramul SK admitted in presence of Sri Gyalsen Lepcha, ACP, SPC acting as Special Executive Magistrate, SPC and other witnesses that they procured the brown sugar clandestinely from elsewhere for the purpose of selling the same in high rate to their designed customer for their personal gain by illegal means. They also disclosed that they have been dealing in such business of procuring and selling of brown sugar illegally for last few months.

Then, I arrested the above noted accused person namely Abdus Samad and Ekramul SK after observing all formalities and informing the ground of their arrest and issued necessary Memo of Arrest.

From the above noted facts and seizure of incriminating articles it is quite evident that the accused persons namely Abdus Samad and Ekramul SK are involved in procuring and selling of brown sugar illegally contravening the norms of NDPS Act.

Under the above circumstances, I pray to you that a specific case under proper section of law may kindly be started against the accused persons namely (i) Abdus Samad (M/28), S/O- Afrajul SK of Mozampur PS. Kaliachak, Dist. Malda and (ii) Ekramul SK (M/38), S/O- Lt. Manzur SK of Mozampur, Mominpara, PS. Kaliachak, Dist. Malda (not verified) and arrange for its investigation.
