Sir,
I, Sri Manoj Paul, Assistant Engineer(E) & Station Manager, Hakimpara CCC, WBSEDCL, Siliguri do here by lodge complaint against present user Alokesh Chakraborty, OM Villa, Swamiji Sarani Siliguri, Dist- Darjeeling for having committed offence as stated here under.
On 26.12.2023 at about 04:20 P.M. acting on a source information I, along with (1) Sri Pranab Sikder, S.O., S&LP Wing, Darjeeling Region, WBSEDCL, (2) Sri Biswajit Ghosh, Sr. T.S.H., Hakimpara CCC and other supporting staff of Mobile van entered OM Villa, Swamiji Sarani, Siliguri and inspected the residential flat of Alokesh Chakraborty at ground floor. During inspection it was found that the electricity was being used illegally at the flat by direct taping from Busbar through a sub energy meter. During inspection it was also found that a load of 1 KW was being drawn unauthorisedly by this manner.

As theft of electricity was detected, the sub energy meter make Indotech, serial no. - 313894 was seized by preparing a formal seizure list duly signed by his representative. The copy of the seizure list handed over to his representative and signature of the representative obtained as token of receipt.


As Alokesh Chakraborty has committed offence u/s 135(1)(a) of the Electricity Act 2003 by doing theft of electricity in the manner as stated above you are requested to take cognizance of the same by treating this complaint as FIR. The seized articles are packed and labelled by me.
