Sub: F.I.R. against Soma Sengupta (Ph No.- 8159984364), AARAV Villa, Swamiji Sarani, Siliguri, Dist- Darjeeling for theft of electricity u/s 135(1)(a) of the Electricity Act 2003.

Sir,

I, Sri Manoj Paul, Assistant Engineer(E) & Station Manager, Hakimpara CCC, WBSEDCL, Siliguri do here by lodge complaint against present user Soma Sengupta, AARAV Villa, Swamiji Sarani Siliguri, Dist- Darjeeling for having committed offence as stated here under.

On 26.12.2023 at about 04:55 P.M. acting on a source information I, along with (1) Sri Pranab Sikder, S.O., S&LP Wing, Darjeeling Region, WBSEDCL, (2) Sri Biswajit Ghosh, Sr. T.S.H., Hakimpara CCC and other supporting staff of Mobile van entered AARAV Villa, Swamiji Sarani, Siliguri and inspected the garage of Soma Sengupta. During inspection it was found that the electricity was being used illegally at the garage by direct taping from Busbar through a sub energy meter. During inspection it was also found that a load of 0.25 KW was being drawn unauthorisedly by this manner.

As theft of electricity was detected, the sub energy meter make Sigma, serial no. - 140280 was seized by preparing a formal seizure list duly signed by her representative. The copy of the seizure list handed over to her representative and signature of the representative obtained as token of receipt.

As Soma Sengupta has committed offence u/s 135(1)(a) of the Electricity Act 2003 by doing theft of electricity in the manner as stated above you are requested to take cognizance of the same by treating this complaint as FIR. The seized articles are packed and labelled by me.
