
With due respect, I am producing herewith the 03 (three) arrested accused persons namely (i) Pradip Kumar (28), S/o- Ram Surat Mahato of Vill- Maharajpur, Nayatola, PO- Kalyani, PS- Teljhari, Dist- Sahebganj (Jharkhand), (ii) Rabi Kumar Mahato (20), S/o- Raju Mahato of Vill- - Maharajpur, Nayatola, PO- Kalyani, PS- Teljhari, Dist- Sahebganj (Jharkhand) and (iii) Sib Sankar Sikdar (28), S/o- Lt. Nipen Sikdar of Jaynagar Colony, Purba Dhantala, PS- NJP, Dist- Jalpaiguri and the following articles under seizure :-

1. One iron rod measuring approx 30 cm in length, one screw driver from the possession of accused named Pradip Kumar.
2. One bhojali, one torch light and from the possession of accused named Rabi Kumar mahato.
3. One wrench, one small iron rod from the possession of accused named Sib Sankar Sikdar.

I, ASI Khagen Barman of New Jalpaiguri PS, Siliguri Police Commissionerate beg to state that on 27.12.2023 at 18.35 hrs, I received a secret source information that a gang of miscreants were assembled at Kachagoli near Truck Stand, PS- NJP, Dist.- Jalpaiguri with deadly weapons and making preparation for committing dacoity at NJP area. Accordingly, I informed the fact to you and diarized the matter vide NJP PS GDE No- 1449, Dated- 27.12.2023. As per kind order myself along with C/453 Uttam Dey, C/1520 Abdul Kayum Mia, VP/13 Jamirul Islam, CV/306 Biswajit Roy all are of New Jalpaiguri PS, Siliguri Police Commissionerate left for Kachagoli, PS- NJP, Dist.- Jalpaiguri to work out the information in hand. At about 18.55 hrs on 27.12.2023 we arrived at Kachagoli near truck stand NJP PS. After arrival of the spot and as identified by the source we found that 10/12 persons were assembled in a dark place at Kachagoli near Truck Stand, PS- NJP, Dist- Jalpaiguri and they were whispering in a very low voice. Accordingly we cordoned the place properly and approach towards them very slowly and carefully. But seeing the police party they started to flee away but we managed to apprehended 03 (three) persons of them. On interrogation the apprehended accused persons, they disclosed their name and identity as noted above (not verified) and also disclosed that they assembled there to commit dacoity in a house at NJP area. They also stated that others 07/09 associates were able to fled away from the spot by taking advantages of darkness. On being searched of the apprehended accused persons, found the above noted articles. Accordingly, I seized the above noted articles under proper seizure list and arrested the above noted 03 (three) accused persons under proper memo of arrest and observing all the formalities of arrest. The search seizure and arrest made in between 19.05 hrs to 19.40 hrs on 27.12.2023.

Under the above noted fact and circumstance, I therefore pray to you that a specific case under proper section of law may kindly be started against the arrested accused persons namely (i) Pradip Kumar (28), S/o- Ram Surat Mahato of Vill- Maharajpur, Nayatola, PO- Kalyani, PS- Teljhari, Dist- Sahebganj (Jharkhand), (ii) Rabi Kumar Mahato (20), S/o- Raju Mahato of Vill- - Maharajpur, Nayatola, PO- Kalyani, PS- Teljhari, Dist- Sahebganj (Jharkhand) and (iii) Sib Sankar Sikdar (28), S/o- Lt. Nipen Sikdar of Jaynagar Colony, Purba Dhantala, PS- NJP, Dist- Jalpaiguri and others and arrange for its investigation.
