I, Smt. Arati Mishra, Wife of Anjay Kumar Mishra, Resident of Binnaguri, Nawapara, P.S. NJP, Dist. Jalpaiguri, Pin-735135 would like to complaint for your kind information and necessary actions:

1. That on 25/12/2023 at about 6 PM in the Evening time, two persons namely 1. Nimesh Kumar Sharma, Son of Sunita Sharma, resident of Ghorarbari, Bholamore, P.O. Sahudangi Hat, P.S. New Jalpaiguri, Dist. Jalpaiguri, Mob:- 7002876897 and 2. Amresh Kumar Sharma, Son of Baldev Sharma, resident of Ghorarbari, Bholamore, P.O. Sahudangi Hat, P.S. New Jalpaiguri, Dist. Jalpaiguri, Mob:- 9931816470 along with ten to twelve anti-social elements forcefully entered into my above noted residence when I was alone at my home with lathi and started to physical and mental assault brutally. They both torture upon me by lathi and whatever they found in their hand brutally. They also tear my dress and catches my hair, used filthy languages and uses criminal force to me and forcefully outrage my modesty but in the meantime my husband reached at my home and save me.
2. That they have also snatched my golden Mangal Sutra of Rs. 1,10,000/- and also taken 30,000/- from my wallet at the meantime when I cried for help some other persons reached at my home then they leave me and gone out of the house shouting filthy and sluggish towards me.
3. That all the accused persons threatened me if I will go to Police Station they will surely kill me along with my family members.

Jalpaiguri, Mob:- 9931816470 and their associates. I have to leave my above noted residence for saving me and my family members life. That the aforesaid accused persons are very dangerous in nature and their activities are illegal so how can I survive at the same residence along with my family. I have great mental anxiety, I am passing my day in extreme difficulties.
5. That I am suffering from severe pain in my forehead, I went to Siliguri District Hospital on 26/12/2023 for my treatment from Hospital.

So, therefore, I request you to please take all necessary legal steps against the above noted all culprits for the ends of justice and make all procurement by which I live in the above noted house without any fear.
