It is to inform you that I, Debraj Das, S/O- Kartik Ch Das, DE & SM, Pradhannagar CCC; being empowered by the Electricity Act 2003, do hereby lodge a complaint against PRANAB CHAKRABORTY(USER), S/O- Rabindranath Chakraborty, Address- 45/15, Baghajatin Colony, Pradhannagar, Pin-734003 for unauthorized use of domestic meter(GE0151845) of WBSEDCL for construction purpose.

Today i.e on 27.12.2023(15:30hrs), I came to 45/15, Baghajatin Colony, Pradhannagar, in my official hired vehicle for a routine inspection. I was accompanied by (i) Prakash Dutta, JE(Gr-II),Pradhannagar CCC, (ii)Rabi Sankar Singh, OE , Pradhannagar CCC & other technical staffs of Pradhannagar CCC.

On inspection of the premises (after observing all formalities), I found that the domestic meter GE0151845 (Con Id-412016062) was unauthorizedly being used for construction purpose .The meter is in the name of Rabindranath Chakraborty.

I disconnected the connection & seized the meter, after preparing the seizure list duly signed by the witnesses.

Seized Articles:

- One 1-phase energy meter GE0151845 (P/R-1053) Make-Genus, 240V , 5-30 amp

Sri PRANAB CHAKRABORTY(USER) was not present at the site. His representative Kallol Saha, received the copy Notice, Inspection Note & Seizure list.

As such, PRANAB CHAKRABORTY(USER) has committed unauthorized use of electricity, other than the one intended for.

Please treat this complaint as FIR U/S 135 1(e) of Electricity Act 2003 against PRANAB CHAKRABORTY(USER).
