In producing herewith 01 (one) arrested accused person named Nagendra Sahu (50) s/o Motilal Sahu of Ward No 17 Balua Rampurwa, Balua, West Champaran Bihar under arrest along with following articles under proper seizure. The ground of arrest duly been communicated with him.

(i) One blue colour bag containing 15 (Fifteen) bottles of "ROYAL STAG" containing 750 Ml in each bottle i.e. total  $(750 \times 15) = 11.25$  liters, Blended and bottled by united brothers distilleries(P) Ltd. Pappu Hills, Naharlagun Papum Pare (ARUNACHAL PRADESH) and marked as Exhibit "A" out of which 01 bottle of the same taken as sample for examination and marked as Exhibit "A-1".


I, ASI Sanjib Mukherjee of Pradhan Nagar PS, SPC would like to lodge this written complaint against the above noted arrested accused person named Nagendra Sahu (50) s/o Motilal Sahu of Ward No 17 Balua Rampurwa, Balua, West Champaran Bihar to the effect that today on 28.12.23 at 17.15 hrs I received a specific source information that one person with a blue colour bag in his hand containing illegal liquor is waiting at Siliguri Junction near for a Bihar bound bus. Accordingly, the matter was diarized in General Diary vide Pradhan Nagar PS- GDE No 1653 dated 28.12.23 and informed the fact to the I/C, Pradhan Nagar PS and as per his kind order and direction myself along with ASI Anwar Abedin C/543 Purna Rishi C/ 735 Swapan Sarkar all of Pradhan Nagar PS left for Siliguri Junction to verify the veracity of the information in hand. After arrival at Siliguri Junction and as identified by the source we managed to apprehended one person with a blue colour bag in his possession. On being asked he disclosed his identity as noted above and also disclosed that he collect illegal liquor from one of his supplier of Sikkim with a view to sale the same in Bihar for his wrongful gain. On search the bag found in his possession the above noted illicit liquor recovered from his possession. On demand he failed to produce any valid license/papers in respect of the above noted illicit liquor recovered from his possession. On further interrogation he stated that he is involved in selling and possessing of illegal liquor without any valid license since long for his illegal gain. Accordingly, I seized and labeled the above mentioned illegal illicit liquor under proper seizure list in presence of witnesses and subsequently, arrested the above mentioned accused person named Nagendra Sahu (50) s/o Motilal Sahu of Ward No 17 Balua Rampurwa, Balua, West Champaran Bihar after observing all sorts of formalities at the spot. The whole process of search, seizure and label has been made in between 17.50 hrs to 18.15 hrs.

Under the above noted fact and circumstances I, pray before your good self that specific case may kindly be initiated against the accused person namely Nagendra Sahu (50) s/o Motilal Sahu of Ward No 17 Balua Rampurwa, Balua, West Champaran Bihar under proper section of law and may arrange to cause its investigation for violation of rules and norms of Bengal Excise Act.
