Sir,

In producing here with one seized vehicle (truck) bearing registration no WB73 A 9343, loaded with river bed materials, I PSI Arindam Saha of Matigara P.S do hereby lodge written complaint to the effect that on 28.12.2023 at 20:35 hrs I received a information from reliable source that one vehicle(truck) bearing Reg. no WB73 A 9343 being loaded with river bed materials coming from Rana Nagar balason river side towards Matigara. On receiving the information I inform the matter to OC PS and as per his kind instruction of I along with available force rush to spot near Shiv temple at Patiramjote under Matigara P.S area and found one vehicle truck being loaded with river bed materials going towards Matigara. Subsequently, I signalled to stop the vehicle. The driver stop the vehicle and on asking supporting documents in respect of the loaded river bed materials he manage to flee away from the spot leaving behind the vehicle .

As such I seized the vehicle (truck) bearing Reg. no WB73 A 9343 under proper seizure list U/S- 102 Cr.P.C in presence of available witnesses as stolen recovery property loaded river bed materials seized in between 20:55 hrs 21:15 hrs and brought at P.S.

Therefore I pray before you a specific case may kindly be started against the owner / driver of the seized vehicle (truck) bearing Reg. no WB73 A 9343 under proper section of law and arrange for its investigation.
