for having committed offence as stated here under.

On 26.12.2023 at about 05:40 P.M. acting on a source information I, along with 1) Sri Pranab Sikder, S.O., S&LP Wing, Darjeeling Region, WBSEDCL, (2) Sri Biswajit Ghosh, Sr. T.S.H., Hakimpara CCC and other supporting staff of Mobile van entered OM Villa, Swamiji Sarani, Siliguri and inspected the common service installation and metering installation of Consumer ID 402656420 in the name of Om Prakash Agarwal. During inspection it was found that the electricity was being used for common services like water pump, common staircase and passage lights illegally by bypassing the common energy meter. It was also observed that a load of 2 KW is being drawn unauthorisedly by this manner.

As theft of electricity was detected, the energy meter make Bentec India Ltd, serial no. - BF016333 installed against Con Id. 402656420 was seized by preparing a formal seizure list. The copy of the seizure list handed over to the representative of Om Prakash Agarwal and his signature obtained as token of receipt.

As Om Prakash Agarwal has committed offence u/s 135(1)(a) of the Electricity Act 2003 by doing theft of electricity in the manner as stated above you are requested to take cognizance of the same by treating this complaint as FIR. The seized articles are packed and labelled by me.
