Sub: Written Complaint

Sir,

I, Shantanu Paul, Son of Late Satyajyoti Paul, resident of 55, Pritikata Road, 558 Surja Nagar, Union Bank Building, No. 01 Dabgram, P.S.- Siliguri Dist.- Darjeeling hereby inform you that in the month of December, 2016, while I was suffering from serious financial crisis, had taken a cash sum of Rs. 25,000/- only from one *Sonatan Chandra Ghosh, Son of Dukal Chandra Ghosh, resident of Gital Para, Haiderpara, Iskon Mandir Road, Ward No. 40, PS- Bhaktinagar, Dist- Jalpaiguri, Pin NO. 734006 but presently residing at Setumore, Old Makka, having Contact No. 9749545411*, out of good relation. However, while taking the said sum of money, the aforesaid Sanatan Chandra Ghosh had categorically taken a signed cheque of Union Bank of India, Branch: Dabgram from me as security and I out of good faith and trust upon him had provided the same. But presently, I am not able to recall the cheque number of the said cheque. However, the said cheque belonged from Cheque Book having No. 02030901 to 02030950 which was issued in respect of Acc. No. 574301010050533. Thereafter, with the elapse of time, all his dues and liabilities were cleared and the said amount and extra charges was also deposited to his SBI account being No. 20265520291 and his Loan account being no. 574305140000002 by me; but in the meanwhile, I forgot that the said cheque was left with him. And since last few days, the said Sanatan Chandra Ghosh has been disturbing me on numerous occasions and demanding me to pay him a sum of Rs. 10,00,000/- (Ten Lakhs Only) failing which, he would use the said cheque misappropriately against me to file numerous false cases against me. That apart, he has also been giving me death threats. The said Sanatan Chandra Ghosh had dishonestly had purposefully taken the cheque for cheating me. And now, he has been taking undue advantage of the same and threatening me with dire consequences.

Thereafter, you are requested to take appropriate legal actions against Sanatan Chandra Ghosh. And oblige.
