I, Prashanta Kumar Mahato, s/o- Mr. Dilip Kumar Mahato, Assistant Engineer and Station Manager, Milanpally CCC, WBSEDCL do hereby lodge this complaint against **Smt. Poonam Kurmi Sarkar** for unauthorized usage of Domestic Electric Connection having Con\_ID: 412093007, Meter No.:HE0093832 for commercial purpose to use the line unauthorisedly and thereby liable u/s 135(1)(e) of Electricity Act, 2003.

On dated:28.12.2023, about 01:10 pm, I along with Sri Pranab Sikdar, SO, Darjeeling Region, and other supporting staff of Mobile Van visited the said premises for inspection. During inspection it was found that the consumer was using Domestic Electric Connection for commercial purpose (**Shop Styled as Jeet's Enterprise: Deals in Mobile & Computer Accessories**) illegally and unauthorisedly.

According, I issued notice and served a copy to the consumer present at site. As the unauthorized use of electricity detected, the service connection has been disconnected and corresponding energy meter & cable used for theft was seized. **The contractual load found was 1.18 kVA.**

**Smt. Poonam Kurmi Sarkar** committed an offence u/s 135(1)(e) of Electricity Act, 2003.

Hence, you are requested to lodge an FIR against the said consumer **Smt. Poonam Kurmi Sarkar** and arrange for its investigation
