Sir,

In producing herewith 02(Two) arrested persons namely 1.Mourali Roy, S/O- Lt. Harendra Roy of Vill-Suryasen Colony, W/No-34, PO-Bhaktinagar, PS-New Jalpaiguri, Dist-Jalpaiguri, 2.Goutam Sikdar, S/O-Dhaniram Sikdar of Vill-Santoshinagar, P.O+PS-Siliguri, Dist-Darjeeling, Paddler of Toto (E-rickshaw), without number plate, Red & Grey Colour along with their Totos under seizer, I PSI(AB) Bipul Barman of Jalpaimore Traffic Guard, Siliguri Police Commissionerate do hereby lodge written complaint against them to the effect that, on 28.12.2023 at about 20:15 hrs I along with ASI(UB) 412 Partha Paul, C-203 Dipen Barman while performing traffic regulation duty at Bardwan Road, Jalpaimore PS- Siliguri, Dist-Darjeeling found that, the above noted persons were plying their Totos (E-rickshaw), as noted above on SH-12 by violating Govt. Order vide **Notification number 1526/1(1)/-WT/3M-56/13/PT.II Dated-27.04.2015 of Principal Secretary to the Govt. of West Bengal** and also disrupting the free flow of traffic by stopping here and there disorderly for collect passengers.

Accordingly, I along with force apprehended them and on asking they could not produce any valid documents nor could able to express any satisfactory reason to do like so. Further asking they stated their name and address as noted above.

Finding no any alternative way I arrested them u/s 41 Cr. P.C and seized these Totos from their possession u/s 102 Cr. P.C by preparing proper arrest memo and seizure list and brought them to Siliguri Police Station for custody.

I, therefore, pray before your kindness that, kindly lodge a specific case in proper section of law against them for violating Govt. order and obstructing for free flow traffic movement and arrange for its proper investigation.
