l, Prashanta Kumar Mahato, s/o- Mr. Dilip Kumar Mahato, presently Assistant Engineer and Station Manager, Milanpally CCC do hereby lodge this complaint that today at about 04:00 pm hours while undergoing routine Deemed Disconnection visit along with Mr. Tapash Chakraborty, OSH, Milanpally CCC, Mr. Niladri Paul, Spot Bill supervisor, Milanpally CCC and other technical personnel has been to the spot at Santoshi Nagar, near Bishnu Mandir, in the premises of Anandi Mahato.

After issuing notice to the representative of Anandi Mahato, we check the departmental meter (Sl. No.: L0755333 and ID No: 412080066) found that his Domestic connection was issued to him. Subsequently, due to non-payment of outstanding dues of Rs. 18,985 within 6 months of disconnection, the connection was declared as deemed disconnected on 08th April, 2022 as per WBERC regulation 55.

On physical inspection, it has been detected that said Anandi Mahato reconnected the line with the WBSEDCL energy meter with help of copper cable, Cutout and Isolator and enjoying the electricity energy since 08th April, 2022 and using electric connection for domestic purpose. The consumer did this intentionally for his wrongful gain.

The contractual load found is 1.18 kva and the final reading of meter is 24375 ckwh.

An Inspection memo and seizure list has been has been prepared by seizing the energy meter in presence of witness and supplied copies of it to the representatives of the Anandi Mahato.

As Anandi Mahato has committed an offence, punishable under section 135(1) (a) and u/s 138(1)(b) of Electricity Act, you are requested to registor and FIR against the accused.
