, Dist- Darjeeling, do hereby make this written complaint before
you stating as follows :

1. That I purchased land measuring 6 Bigha, Rupni (As per ROR)
recorded in Khatian No. 19, R.S Plot No. 22, L.R Plot No.16,
J.L No. 53, Mouza - Dhukuria, J.L. No. 53, Under Patharghata
Gram Panchayat, touzi No. 91, P.S.-Matigara, Sub-Division
Office- Siliguri, B.L. & L.R.O. Matigara, Add District Sub-
Registry Office, Siliguri-II at Bagdogra, District-Darjeeling vide
Deed of Sale being No. I-201 for the year 2020 registered at the
office of the D.S.R., Darjeeling executed by Sri Animesh

4. That on 24/12/2023 at about 11.00/11.30 a.m I was informed that one Smt. Leela Bhutia, w/o Late M.D Bhutia, r/o Sukhiapokri, P.O & P.S - Sukhiapokri, Dist - Darjeeling presently residing at Methibari, P.O - Salbari, P.s - Pradhan Nagar, Dist - Darjeeling along with Miss Santosh Tamang, d/o Sri D.M. Lama, Smt. Nirmala Tamang, w/o Lt. U.M Lama, both r/o Singmari, P.O & P.S & Dist - Darjeeling, Sri Santosh Tamang @ Rai and others have come to the aforesaid land and tried to encroach the said land by making wooden structure.

5. That on getting this information I came to the land and saw the aforesaid persons trespassed into the land with an intention to grab the land.

6. That when I protested and tried to restrain them from illegally grabbing my land they got furious and started to quarrel with me and also threatened me to go from the land otherwise I shall have to face dire consequences with life.

Several other persons of the locality supported me and seeing the crowd they fled away but have threatened me that they would come again with more persons and take steps for grabbing the land.

In the circumstances I reasonably apprehend and believe that the aforesaid persons may again come to the below scheduled land for the purpose of grabbing the land so I make this complaint for taking necessary action against those persons and for protection of the below scheduled land.
