

That, in the month of May 2010, I was compelled to leave my matrimonial house as I was assaulted by my husband and also due to the cruelty meted out to me by the mother-in-law and sister-in law. I shifted to a rented premises near Bagdogra airport. Later on my husband followed me and started living with me by making a promise that he would never misbehave with me. However he did not keep his words and continued to misbehave with me.

That, in the year of 2016, I was expecting my 2nd child and at time my husband left for Delhi for job. The rent in Bagdogra was very high and was difficult for me to afford alone. Therefore I decided to move to my matrimonial house but my mother-in-law did not allow me to stay at the matrimonial house. Therefore having no other option left I moved to my parental house at Guwahati. A floor of a residential was given to me. Later on my husband along with his mother also shifted there. Since 2016 I am staying at my parental house at Guwahati.

That, during his stay at Guwahati my husband after getting drunk used to behave abnormally with my mother. After getting drunk he used to destroy the household goods and used to create chaos in the locality and thereby embarrassing me and my family members. Due to such activities of my husband the relatives and the neighbouring people also started complaining about him.

That, in the month of April 2021 my husband left me and started living separately in Guwahati. He was not taking any responsibility of me and our children I had doubts that the my husband was having an extra marital affair but I could not take any step because I had no proof regarding his activities. I am now aware of the fact that the Opposite Party is having extra marital affairs with multiple women from the photographs I have obtained from his mobile phone.


Now my husband has solemnised his second marriage without getting divorce from me. His second wife is staying at his parental house and was supported by his family members in solemnization of the marriage.
