
Respected Sir,

I, **PANKAJ KUMAR SHAW**, S/O Shankar Shaw, resident of Baghajatin Colony, P.O. & P.S.Pradhan Nagar, Dist. Darjeeling, I do here by want to inform you as follows :-

1. That I work under Aman Kumar Sah, S/O Late Haricharan Sah at Regulated Market (Fish Complex), Mallaguri, P.O & P.S. Pradhan Nagar, Dist- Darjeeling, as a collection agent since long.
2. That subsequently on 29.12.2023 at the early morning at around 9:00 am one person namely **RAKESH MAHATO** bearing Phone No. 7679079702 who are also working at Regulated Market (Fish Complex), Mallaguri, P.O & P.S. Pradhan Nagar, Dist- Darjeeling had come to the "Fish Gaddi" of Aman Kumar Sah, S S/O Late Haricharan Sah, and purchased fish from his "Fish Gaddi" on a credit basis and also asked me to collect the money from them later.
3. That subsequently after few hours when I as a collection agent visited the for collecting money, then the said **RAKESH MAHATO and his brother ASHOK MAHATO** along with other anti -social persons started to beat me mercilessly, used abusive languages on me and also started to threatening me to kill me.
4. That thereafter when I protested against these illegal activities then they came in a aggressive manner and started to threatened me that if I again ask for money then they will me and started to beat me mercilessly with icks and blows
5. That thereafter suddenly came with the weapons namely iron puncher, iron rods and harmful kitchen tools like "Botti" / vegetable cutting iron blade and started to beat me mercilessly strangulated me and attacked me with those harmful tools with an intention to kill me.
6. That subsequently I somehow escaped and started to run to save my self then they threatened that if try to go to the Police Station to take any legal action against them then they will kill my family members in the house and then they started to chase me but somehow I saved myself from the said placed and hide my self.

7. That I sustained severe injuries on head, forehead, ear, eyes etc., and on various parts of my body and I am still admitted at the Hospital and is in a serious condition for severe injuries.
8. That the above named persons are very much desperate and started to threatened us that they will take revenge from us by killing all my family members.
9. That still that accused person as they are too much desperate in nature did not allow me to stay in my house peacefully and as a result we has to spent our days as bewildered condition and the life and dignity and honour of us are in danger and we are passing our days with great fear/tension/anxiety for the continuous threat given by above named accused persons.
10. That I am a helpless person and seeking justice from you by taking necessary legal action against the accused culprits, namely **RAKESH MAHATO and his brother ASHOK MAHATO** along with other anti -social persons, working at Regulated Market (Fish Complex), Mallaguri, P.O & P.S. Pradhan Nagar, Dist- Darjeeling, and take the necessary legal steps as our life are in very much danger and the above named accused persons can any time attack us.
