Ltd. is a reputed company and deals with best windows and doors. Mr. Arindam having contact number 9830111390 representing as the owner of Winpard Infracon Pvt. Ltd. and Subhajit Banik having contact number 8100102327 representing as the local (Siliguri) agent have also talked with us and convinced us to purchase their products. As we were/are going to open a Hospital at Tinbatti More in the name of "Star Hospital" on good faith upon them told them to send the offer letters/quotation of the articles according they also send the offer letter dated 26.07.2023 along with terms and conditions to us. Subsequently as per the demand of said Debtanu, Arindam and Subhajit we have made payments amounting of Rs.4,31,528/- and Rs.65,826.26 invoice dated 28.09.2023 further amounting of Rs.5,82,146/- and Rs.88,801,92 invoice dated 26.10.2023 and labour charges amounting of Rs.28,320/- invoice dated 26.10.2023. But after making payments inspite of several request they did not send the articles within time.
