Bishnu Narayan Mishra physically tortured
me and tried to kill me by putting a
sleeping pillow on my face.

Some how I could save my self by promising
to fulfill their dowry demands but when
my parents couldnot fulfill their demands
they again tortured me physically and
mentally even though I conceived.

Many a times they threatened me to kill
my baby who is still in the womb.

In the month of October my husband and my inlaws kicked me out of my matrimonial house and I took shelter at my sister's house at Ghorabari. Since then my husband and my inlaws did not spare me of threatening me with dire consequences.

That on 25th of December 2023 my parents went to their house to talk about my future but they did not respond properly and when my parents insisted the matter they physically assaulted my parents and kicked them out of their house.

I did not report to the police due to my illness as I am seven months pregnant.

My husband and my inlaws are very dangerous and may kill me at any point of time. Hence I request you to kindly take notice of the fact and do the needful at the earliest.
