I, SI Dwipendra Nath Bakshi do hereby lodge this complaint against the above noted accused persons to the effect that on 30/12/23 I along with force was detailed for performing community service van under Bhaktinagar PS area vide Bhaktinagar PS GDE No 1355 dated 30/12/23 . During discharging my duty I have received an information from my source that Nasha Disco and Pub which is situated bellow cosmos Mall was performing live vocal music inside the said pub without any Govt. permission . Accordingly the matter was apprized to I.C Bhaktinagar PS and as per his direction I along with force had been the inside the Pub premises and found that there is performing live vocal music by the look after by the above noted persons . Hence, I asked them to produce the license/permission u/s 239 as per Govt. provision, but they fail to produce the same , then the entire fact was communicated to I.C Bhaktinagar PS. Accordingly as per kind direction of I.C Bhaktinagar PS I, apprehended the above noted accused persons by the help of other force after maintain all formalities as per guidelines and issued memo of arrest U/S 41 Cr.P.C.

I, therefore, pray that a specific case may kindly be started against the above mentioned 06(Six) accused persons under proper section of law for violating the provision of Govt. order
