

This is to inform you that I Bijay Prasad Age 72
resident of Seth sri Lal market compound siliguri - 1
P.S - siliguri Police station, today ^{30/12/23} at around 7:30
Pm I with my wife Saroj Prasad. Age 67 years
was going to the party of Shri Bipin Bihari Gupta
Just after ^{locking} my gate when I was try to come out of
my gali, ~~the~~ Lalit Agarwal with his son Nishant Agarwal
was standing in the middle of the passage without any
space left for movement and coming out of the gali
obstructing the passage when I request them to
move aside and give some space to go out they started
to use abusive language and threatening me
of dire consequence if again I utter a word,
I then said why kind of language are you using
they started to use filthy language and started
to beat me with their hand

in my stomach, chest then one of his son Vivek Agarwal also joined them and started beating me. Seeing this my wife tried to save me but they also started to beat her. Hearing the noise my son Harish Prasad who has just returned today from Hyderabad after his stomach treatment he came down and tried to save us but they also started to beat him causing us serious ^{internal} injuries. Then all three of them has threatened to kill us with dire consequence. They all are the resident of Seth Sri Lal market compound and neighbours.

They are ~~habitual~~ habitually threat us and create lot of problem to us. After the incident we went to Siliguri hospital because we were in pain and mental trauma. The medical prescription is attached with. I and my wife is a senior citizen and most of the time we stay alone as my son goes out for work. I feel like insecurity and traumatized seeing them. Please help me and take strict action against them.
