SUB: First Information Report

Sir,

I, Shri. Bhola Das, S/o late Keshab Das, R/o of Rangapani, P.O. Rangapani, P.S. Bagdogra, Dist - Darjeeling, would like to inform you as follows:

1. That the Ld. Civil Judge (Junior Division) at Siliguri passed an order on 25/7/2023 in Title Suit Case No. 215/17, as follows:

*"That the instant prayer of temporary injunction as prayed by the plaintiff is hereby considered and allowed on contest against defendants no. 1 and 2 and on ex parte hearing against defendant no. 3.*

*The defendants are hereby restrained from entering into the suit property and also from disturbing peaceful possession of the plaintiff over the same till disposal of the suit."*

2. That today at around 11:00 AM, when I was on my land at that time the defendants of the above mentioned Title Suit namely Anil Chowdhury, Ravi Chowdhury, both son of Ashu Chowdhury and Chitta Chowdhury, son of Shri. Binod Chowdhury, all are residents of Rangapani, P.O. Rangapani, P.S. Bagdogra, Dist - Darjeeling, entered into my land by violating the order of the Ld. Court and started to use filthy and insulting language towards me without any reason and threaten me to leave the land immediately otherwise they will kill me. I raised strong protest against them and managed to restrain them, but while leaving they threatened me with dire consequences and told me that they will at any cost encroach my land.

Sir, they are very dangerous and desperate nature of person and they can do anything to encroach my land and they do not have minimum respect on the law of the land.

I, therefore request you to take appropriate legal action against the above named accused persons.
