1. That the Ld. Civil Judge (Junior Division) at Siliguri passed an order on 25/7/2023 in Title Suit Case No. 215/17, as follows:

"That the instant prayer of temporary injunction as prayed by the plaintiff is hereby considered and allowed on contest against defendants no. 1 and 2 and on exparte hearing against defendant no. 3.
