It is to inform you that I, Debraj Das, S/O- Kartik Ch Das, DE & SM, Pradhannagar CCC; being empowered by the Electricity Act 2003, do hereby lodge a complaint against PRAMOD KR SINGH, S/O- Lt Bhrigu Nath Singh, Address- Prafullah Nagar, Pradhannagar, Pin-734003 for unauthorized use of domestic meter(L1685122) of WBSEDCL for commercial purpose.

Today i.e on 02.01.2024(13:45hrs), I came to Prafullah Nagar, Pradhannagar, in my official hired vehicle for a routine inspection. I was accompanied by (i)Rabi Sankar Singh, OE, Pradhannagar CCC; (ii) Gunjan Tamang, SrTSH, Pradhannagar CCC & other technical staffs of Pradhannagar CCC.

On inspection of the premises (after observing all formalities), I found that the domestic meter L1685122 (Con Id- 400218868) was unauthorizedly being used for commercial purpose (running a Medicine Shop-KAVYA MEDICO). The I disconnected the connection & seized the meter, after preparing the seizure list duly signed by the witnesses.

Seized Articles:

- One 1-phase energy meter L1685122 (P/R-48539) Make-Landys Gr, 240V, 5-30 amp

PRAMOD KR SINGH was present at the site & received the copy Notice, Inspection Note & Seizure list.

As such, PRAMOD KR SINGH has committed unauthorized use of electricity, other than the one intended for.

Please treat this complaint as FIR U/S 135 1(e) of Electricity Act 2003 against PRAMOD KR SINGH.
