Sir,

It is to inform you that I, Debraj Das, S/O- Kartik Ch Das, DE & SM, Pradhannagar CCC; being empowered by the Electricity Act 2003, do hereby lodge a complaint against **PUSHPA MAINALI(USER)**, W/O- Lt Shankar Mainali, Address- Prafullah Nagar, Pradhannagar, Pin-734003 for unauthorized use of domestic meter(**IPB248248**) of WBSEDCL for commercial purpose.

Today i.e on **02.01.2024**(13:20hrs), I came to Prafullah Nagar, Pradhannagar, in my official hired vehicle for a routine inspection. I was accompanied by (i)Rabi Sankar Singh, OE , Pradhannagar CCC; (ii) Gunjan Tamamg, SrTSH, Pradhannagar CCC & other technical staffs of Pradhannagar CCC.

On inspection of the premises (after observing all formalities), I found that the domestic meter **IPB248248** (Con Id- **412072698**) was unauthorizedly being used for commercial purpose (running BANDHAN BANK). The meter is in the name of SHANKAR MAINALI.

I disconnected the connection & seized the meter, after preparing the seizure list duly signed by the witnesses.

Seized Articles:

- One 1-phase energy meter **IPB248248** (P/R-18402) Make-Bentec, 240V , 5-30 amp

PUSHPA MAINALI(USER) was present at the site & received the copy Notice, Inspection Note & Seizure list.

As such, **PUSHPA MAINALI(USER)** has committed unauthorized use of electricity, other than the one intended for.

Please treat this complaint as FIR **U/S 135 1(e)** of Electricity Act 2003 against **PUSHPA MAINALI(USER)**.
