Sir,

I, **MAMONI BISWAS**, daughter of late Kartick Biswas, at present residing at C/o. Ramesh Biswas, Vill. Kawakhali New township (beside handicap school), P.O. Sushrutanagar, P.S. Matigara, Dist. Darjeeling, would like to inform you that on 14.07.2023 I had lodge one written complaint against one **SWAPAN BARMAN** son of "unknown" resident of shivmandir, P.O. & P.S. Matigara, Dist. Darjeeling before the O.C. Bagdogra P.S. and as per which a criminal case was initiated against said **SWAPAN BARMAN** vide Bagdogra P.S. case No. 325/23, U/S. 376 of IPC. Initially few months said **SWAPAN BARMAN** couldn't able to establish any contact with me and my mother but on 08.12.2023 said **SWAPAN BARMAN** suddenly made a phone call by his phone number 8391048332 and then consistently made several phone calls through his another phone number 8972502646. I warned him not to disturb me and my mother again but in vain. Since 08.12.2023 he consistently contacted me through various numbers through phone calls, text messages and even contacted me on my Whatsapp, Instagram and facebook and blackmailed me that if I don't engage in a love relationship with him than it I will face severe consequences but I ignored him and blocked him on the above social medias. On 28.12.2023 at about 7.30 P.M. I discovered that I had I received one friend request on my facebook account through an account namely **PREM SAHA** which had many mutual friends with my facebook account, when I casually accepted it I found that said account had posted my intimate videos and voice recordings with said **SWAPAN BARMAN** in its "stories and status updates". Moreover he even posted my intimate photos and our joined pictures in the profile picture of said facebook account and also shared my intimate picture and videos in my comment box of my facebook account. He even shared all the above pictures and photos with my near relatives and friends. He threatened me via my friends and relatives that he will make various fake id's and continue to share all the above intimate and private pictures until and unless I agree to get into a love relationship with him. Finding no other way out I unblocked him in whatsapp and contacted him and begged him to not to continue all this criminal activities he threatened me he will never stop sharing and posting all the above pictures and videos and will also compel me to commit suicide. He then opened four (4) fake accounts in the name of **PREM SAHA** in facebook and shared all the above intimate pictures and videos with him. After this incident I was totally shattered and was disoriented and was thinking of committing suicide but after the intervention of my friends and well wishes I regained hope and as such I decided to lodge a written complaint against. Hence this is the cause of my delay in lodging this complaint.

I therefore request you to kindly take necessary legal steps against said **SWAPAN BARMAN** and kindly provide me justice. I shall be highly obliged to you forever.
