With due respect, I, Smt Anita Barman, Wife of Sri Haradar Barman resident of Middle Palash, Champasari, P.O Champasari, P.S Pradhan Nagar, Dist Darjeeling(West Bengal) begs to state that my marriage was solemnized with Haradar Barman in the Month of June 1998 under Hindu Rites and custom. That due to our wedlock three children was born namely Amit Barman, Sukhdeb Barman and Laxmi Barman. That my elder son's Amit Barman and daughter Laxmi Barman are married. That my husband without giving me divorce, again got re-married with Jhori Barman in the year 2019 and since then he is/was living separately from me.

That my husband on regular interval used to come to our place of residence and used to torture me physically and mentally. I used to bear such torture considering my social status and status of my father-in law. That today at around 10.30 A.M. suddenly my elder son Amit Barman and my husband Haradar Barman came to place of residence and without any rimes and reason started quarrelling with me. That my husband apprehended me inside my living room and they jointly tried to strangle me with a bed sheet. That my husband and my elder son Amit Barman tried to kill me by strangulation. They also sprayed kerosene oil over me and tried to light me on fire. That I somehow managed to escape from the grip of my husband and my elder son. That my husband and my elder son make a call from 8101054733 to my younger son number 9641932981 with a threat that they shall kill me with sharp weapon, if I return back to my home. That I make a call to my father in law and after some time my father in law and Mother in law came to Champasari and thereafter I along with my father in law when I went to my place of residence I found that my husband was standing near my house with a sharp weapon and I seeing this I along with my father in law I returned back. That they are regularly calling me and threatening me with dire consequences even now.


So, I therefore request before you to kindly look into the matter and do the needful. I shall be highly obliged for this act of kindness.
