Dear Sir,

I, Ms. Tapshi Paul, Daughter of Sri Tapan Paul, resident of Sukantapally, Shaktigarh, Ward No.39 of the Siliguri Municipal Corporation, Police Station - Siliguri, Post Office - Siliguri Bazar, District - Darjeeling, PIN-734005, West Bengal would like inform you that on 01.01.2024 at around 01:30 a.m. approx. as I left a restaurant situated at Vega Circle, Salugara after new year celebrations and was returning back to my home and as it was too late my friend namely Nihal Kothari amongst others accompanied to drop me home. As we were moving towards Sevoke Road just Opposite Gateway Hotel a group of 15-20 unknown men gathered and started to create ruckus and banged the back and the windshield of the car and accordingly my friend had no other option but to stop the car and as I opened the window and questioned them as to why did they bang the car, one of the unknown persons from the group put his hand on my shirt and touched me inappropriately and as a consequence pulled out my shirt buttons. Reacting to this my friend questioned him "Yeh kya kar raha hai?" immediately upon hearing this the unknown person rushed at my friend's side and pulled out my friend from the car and rained fist kicks and blows at my friend, they manhandled my friend and physically assaulted him. They abused us with filthy words. The group thereafter started pelting stones at my friend's car. Thereafter we somehow managed to escape from the place and reached home.

As I was in a complete state of shock and this entire incident tormented me both physically and mentally and took a toll on my health, I could not lodge this complaint immediately and hence this delay in lodging this complaint.

Sir, the entire incident is captured in the CCTV footage in and around Gateway hotel and all the unknown men were young men in their twenties. I therefore request you to take note of the aforesaid fact and take necessary action against unknown men in accordance with law and oblige.
