Sir, I Chetan Kharga, Son of Late Prem Kumar Kharga, resident of Himgiri Apartment, Baghajatin Colony, Ward No:45 of SMC, PO&PS:- Pradhan Nagar, Dist:-Darjeeling would like to inform you that I am a owner of a land measuring about 2 Katha along with Tin Shed House, being Corporation Holding Number:- 475/A/13/2/N Situated at Surya Sen Colony, Ward No:-1 of SMC, PO & PS:- Pradhan Nagar, District :- Darjeeling.

On several occasion Two Persons namely, Biplab Chowdhury and Priyanka Chowdhury along with their men and persons came to my land and threatened me with dire consequences and forcibly tried to capture my land for their illegal gain but when I raised strong protest, Biplab Chowdhury and Priyanka Chowdhury being a schedule caste threatened me that they will file a fake SC & ST Act case against me so that I will leave my land. And Always they were threatening me that if they once filed a SC & ST Act Case No one can save me from that case.
