Respected Sir,

I, Aslam Sikder, Son of Late Abul Kashim Sikder, resident of Ashraf Nagar, Ward No.40 of S.M.C. P.O. Haiderpara, P.S. Bhakti Nagar, Dist. Jalpaiguri, would like to report you the following facts:-

1. That Md. Rohit Sikder is my son.
2. That on 16.12.2023, at about 8:40 p.m. when my younger son Md. Rohit Sikder and nephew namely Md. Imran Sikder play at that time quarrel arose between them on small talk of children at that time (i) Sababana Parvin , Wife of Pintu Sikder, (ii) Bina Sikder, Wife of Lukman Sikder, (iii) Lukman Sikder, Husband of Bina Sikder, (iv) Pintu Sikder, Son of Lukman Sikder caught hold my son color and started assaulting him mercilessly by fists, blows and by kicks, they assaulted my son for about 10 to 15 minutes, said Pintu Sikder and Lukman Sikder assaulted my son with iron rod on his head as a result blood was oozing from his head and his whole cloth get wetted of his blood, after such attack, my son became senseless and fell down on the ground, in the

meantime they snatched neck chain of silver of Rs. 6,000/- from his neck, seeing this passersby gathered and scolding them, one of them inform us about the incidents, we rushed to the spot and seeing my son's condition we rushed to the Siliguri S.D. Hospital taking him where my son was treated and he is still under doctor observation.

I, therefore, request you to kindly take necessary legal action against the aforesaid culprits for the commission of the aforesaid offenses by them.
