In producing herewith 03 (three) arrested accused persons named (1) Bikash Khati (25 yrs) S/O Shibu Khati of Durga Nagar Ward No 04, PS- Siliguri, Dist-Darjeeling 2) Dhanu Sarkar (34 yrs) S/O Bimal Sarkar of Suryasen Colony, Ward No 04, PS Dhupguri, Dist Jalpaiguri (3) Dilip Chakraborty (50 yrs) S/O Late Naren Chakraborty of Khutipara near Khutipara Primary School, PS Kotwali, Dist Coochbehar along with seized articles 1) one knife measuring 13" including handle wrapped from the possession of Bikash Khati (25 yrs) S/O Shibu Khati which was kept concealed on the back side waist 2) One iron sword measuring 31" including iron handle recovered from the possession of Dhanu Sarkar (34 yrs) S/O Bimal Sarkar which he was holding on his hand 3) One iron rod measuring approx 28" pointed one end recovered from the possession of Dilip Chakraborty (50 yrs) S/O Late Naren Chakraborty which he was holding on his hand under proper seizure list.


I, SI Krishna Parja of Khalpara TOP Under Siliguri PS/ SPC do here by lodge the written complaint to the effect that on 04/01/2024 at 00:15 hrs I received secret source information that 6-7 persons had assembled at Iznakar More Sabji Bazar, in front of Modern Boys Club ground, Ward No 04 to commit dacoity in the locality. Immediately informed the tip of information to O/C Khalpara TOP and as per his kind instruction myself along with GD book vide Khalpara TOP GDE No 90/2024 dated 04/01/2024 and as per his kind instruction myself along with SI Asim Kumar Das, SI Subhendu Das, ASI Kalachand Singha, C/239 Badal Kr. Barman, C/174 Prady Kr Das, also with K27 van Officer and force left for Iznakar More Sabji Bazar, in front of Modern Boys Club to verify the veracity of the information. At about 00:40 hrs I along with police party arrived at the spot Iznakar More Sabji Bazar, in front of Modern Boys Club and after keeping our vehicle at a distant place we proceeded towards Iznakar More Sabji Bazar, in front of Modern Boys Club on foot and being indicated by the source found from the considerable distance that a gang of six/seven persons were assembled at Iznakar More Sabji Bazar, in front of Modern Boys Club and they were whispering in very low voice. Accordingly, we cordoned the place properly and approach towards them. But seeing the presence of police party, they scattered in multi direction and started fleeing away but after a hot chase manage to apprehended 03(three) persons and others persons fled away from the spot. On interrogation, the apprehended persons disclosed their name, address as noted above, and started giving incoherent statement regarding their presence/gathering in the same place also. On further grilling they stated that they along with others assembled there in preparation to commit dacoity. Accordingly on being search I recovered 1) one knife measuring 13" including handle wrapped from the possession of Bikash Khati (25 yrs) S/O Shibu Khati which was kept concealed on the back side waist 2) One iron sword measuring 31" including iron handle recovered from the possession of Dhanu Sarkar (34 yrs) S/O Bimal Sarkar which he was holding on his hand 3) One iron rod measuring approx 28" pointed one end recovered from the possession of Dilip Chakraborty (50 yrs) S/O Late Naren Chakraborty which he was holding on his hand. Accordingly, I seized the above noted recovered articles as per seizure list in presence of witnesses and duly signed by them in between 01:05 hrs to 01:35 hrs and I arrested them U/S 41 Cr.P.C. after explaining the charges against them.


