Sub: **FIR in respect to Pilferage of Electricity**

Sir,

I do hereby lodge a complaint empowered by the Electricity Act, 2003, read with further amendments that Mrs. Akhtarun Nahar Mondal, W/O- Mr. Abbas Ali Mondal, resident of Maruti Mansion, Rabindra Nagar (Near Fish Market), Ward No.- 21, P.O. - Rabindra Sarani, PS- Siliguri, District- Darjeeling, PIN- 734006 (Consumer ID: 402514344), has committed Theft of Electricity under section: 135(i) (a) & (b) of the Electricity Act, 2003, read with further amendments for the Domestic purpose as stated here under.

On 04.01.2024 at about 11:40 hours, I, Sri Sourav Paul, DE (E) & Station Manager, Subhaspally CCC, WBSEDCL, along with 1. Mr. Pranab Sikdar, Special Officer, attached with S&LP unit, Darjeeling Region Office, WBSEDCL & 2. Mr. Arnab Ray, J.E. (E) (Grade-II) & 3. Mr. Subhasis Manna, Sr. Office Executive, attached with Subhaspally CCC, WBSEDCL, entered into the Domestic premises (Flat) of the accused person, Mrs. Akhtarun Nahar Mondal, W/O- Mr. Abbas Ali Mondal, resident of Maruti Mansion, Rabindra Nagar (Near Fish Market), Ward No.- 21, P.O. - Rabindra Sarani, PS- Siliguri, District- Darjeeling, PIN- 734006 (Consumer ID: 402514344), in order to inspect the service line incoming & leaving the meter as well as Supervisory Checking purpose.

During inspection it has been found that the aforesaid accused, Mrs. Akhtarun Nahar Mondal, W/O- Mr. Abbas Ali Mondal, resident of Maruti Mansion, Rabindra Nagar (Near Fish Market), Ward No.- 21, P.O. - Rabindra Sarani, PS- Siliguri, District- Darjeeling, PIN- 734006 (Consumer ID: 402514344), was consuming Electricity dishonestly in unauthorized manner by Direct Hooking/Tapping by PVC Insulated Aluminum Cable from WBSEDCL's LT Common Bus-bar situated at the ground floor of the apartment called 'Maruti Mansion' by breaking the Seal of the said Bus-bar panel & Bypassing the Metering Arrangement by Hooking wire connected directly to the Distribution Switch Board system of the welding machine avoiding Metering arrangement to run the welding machine at the aforementioned Domestic premises for Domestic purposes having Accessed/Inspected Load 1.0 kW. Hence the meter was unable to record the proper/exact Electrical Energy consumption. Thus WBSEDCL incurred huge amount of loss in revenue.

As Theft was detected I immediately with the help of my Technical staff disconnected her Service Connection as well as the unauthorized connection as per regulation and seized some portion of One No., Two Core, White Colour, PVC Insulated Aluminum Cable, having approx. size of 4.0SQMM each & approx. length 54 feet each (Hooking/Tapping wire) which has been used for Direct Hooking/Tapping-off Electrical Energy from the WBSEDCL's LT Distribution Network (LT Common Bus-bar) & Bypassing the WBSEDCL's Metering Arrangement (Meter Serial No: RBRT11217) by connecting the other end of the Hooking/Tapping wire to the Distribution Switch Board system of the welding machine avoiding Metering arrangement to run the welding machine at the aforementioned Domestic premises for the Domestic purposes dishonestly in unauthorized manner (Both Phase & Neutral Lines were taken by Hooking/Tapping from WBSEDCL's LTOH Distribution Network) under a proper seizure list as well as the seized articles were properly packed, labeled and sealed at the spot after observing necessary formalities viz-a-viz duly signed by the Inspection Team Members & Witnesses & the Accused Person & her local witness i.e. Husband. The inspection team members left the aforesaid premises at 12:30 Hours on the same day after observing all formalities & sealing WBSEDCL's LT Bus-bar.

So the accused Mrs. Akhtarun Nahar Mondal, W/O- Mr. Abbas Ali Mondal, resident of Maruti Mansion, Rabindra Nagar (Near Fish Market), Ward No. - 21, P.O. - Rabindra Sarani, PS- Siliguri, District- Darjeeling, PIN- 734006 (Consumer ID: 402514344), has committed Theft of Electricity under section: 135(i) (a) & (b) of the Electricity Act, 2003, read with further amendments for the Domestic purpose.

So I request you to take cognizance on this matter and consider this complain as FIR to initiate further necessary action from your end.
