No 8372820800 and it is still not reached of since then. Therefore I tried to search my said husband and came to know that with the permission & consent of his parents noted above my said husband is living together with another married woman namely, Smt. Namita Roy Malakar (mother of 02 (two) children) at C/o Smt. Namita Roy Malakar @ Deepali (Mob. No. 8391967433) w/o Not known, presently residing at Sharada More, Pipe Line, Jaleshwari P.S.-Bhakti Nagar, Distt - Julpiguri, when he came back on dt. 18. 12. 2023 & about 06.00 pm at Naturpara Ward No. 5, P.S. - Siliguri, to take his clothes etc. and at that time my said husband abused me in filthy language and he above noted parents abused me over his mobile phone and he beaten me with fist & blows and they all subjected me for physical & mental cruelty.
