

Sir,

In producing herewith two arrested accused persons namely (i) Tenzing Bhuchung Bhutia (45 yrs) S/O Tenzing Thinlay Bhutia of Tenzing House, T.N. Road, Sonada, Khamahal, PS- Jorebanglow, Dist.- Darjeeling and (ii) Gopen Rai (44 yrs) S/O Deokumar Rai of Thanaline, Daragaon, Sonada, PS- Jorebanglow, Dist. Darjeeling under arrest along with following articles under proper seizure list. The ground of arrest duly been communicated with them.

- (i) One paper made cartoon containing 15 (fifteen) bottles of Budweiser Premium King of Beer containing 650 Ml in each bottle i.e. total (15 x 650)= 9.750 liters, and marked as Exhibit "A" out of which 01 bottle of the same taken as sample for examination and marked as Exhibit "A1".
- (ii) One paper made cartoon containing 06 (six) bottles of TUBORG PREMIUM Beer containing 650 Ml in each bottle i.e. total (06 x 650)= 3.900 liters, and marked as Exhibit "B" out of which 01 bottle of the same taken as sample for examination and marked as Exhibit "B1".
- (iii) One small paper made cartoon containing 04 (four) bottles of Budweiser Magnum Premium International Beer containing 650 ml in each bottle i.e. total (4 x 650) = 2.6 ltrs and marked as Exhibit "C" out of which 01 bottle of the same taken as sample for examination and marked as Exhibit "C1".
- (iv) 01 One bottle of SMIRNOFF TRIPLE DISTILLED VODKA containing 750 ml and marked as Exhibit "D".

I, SI Goutam Mallik of Pradhan Nagar PS, SPC would like to lodge this written complaint against the above noted two arrested accused persons namely i) Tenzing Bhuchung Bhutia (45 yrs) S/O Tenzing Thinlay Bhutia of Tenzing House, T.N. Road, Sonada, Khamahal, PS- Jorebanglow, Dist.- Darjeeling and (ii) Gopen Rai (44 yrs) S/O Deokumar Rai of Thanaline, Daragaon, Sonada, PS- Jorebanglow, Dist. Darjeeling and the owner of CHO'Z Restaurant of Salbari, PS- Pradhan Nagar, Dist.- Darjeeling to the effect that on 04.01.24 at 22.15 I received a specific source information that the owner of CHO'Z RESTRO Restaurant situated at Salbari under PS- Pradhan Nagar, Dist.- Darjeeling is selling and storing huge quantity illegal liquor at his restaurant without any valid license. Accordingly, I informed the matter to the I/C, Pradhan Nagar PS and diarized the fact in General diary vide Pradhan Nagar PS GDE No 195 dated 04.01.24 and I/C, Pradhan Nagar PS directed me to work out the information in hand. Accordingly, myself along with SI Kalyan Saha, SI Bandhan Roy and force left for Salbari to verify the veracity of the information in hand. At about 22. 30 hrs we arrived at Salbari and held raid at the Restaurant styled as CHO'Z RESTRO situated at Salbari under PS- Pradhan Nagar, Dist.- Darjeeling and found two persons were engaged for selling illegal liquor at the said restaurant. Accordingly, I managed to apprehended both of them. On being asked they disclosed their identity as noted above and also disclosed that they along with their owner is running this illegal business for selling illegal liquor at the restaurant since long for their wrongful gain. Accordingly, I searched the owner of the said restaurant but found he is absconding. On search the above noted illicit liquor recovered from said restaurant. On demand they failed to produce any valid license/papers for selling and storing of such illicit liquor at their restaurant.


On further interrogation they stated that they along with their owner are involved in selling and possessing of liquor without any valid license since long for their illegal gain. Accordingly, I seized and labeled the above mentioned illegal illicit liquor under proper seizure list in presence of witnesses and subsequently, arrested the above mentioned 02 (two) detain persons namely i) Tenzing Bhuchung Bhutia (45 yrs) S/O Tenzing Thinlay Bhutia of Tenzing House, T.N. Road, Sonada, Khamahal, PS- Jorebanglow, Dist.- Darjeeling and (ii) Gopen Rai (44 yrs) S/O Deokumar Rai of Thanaline, Daragaon, Sonada, PS- Jorebanglow, Dist. Darjeeling after observing all sorts of formalities at the spot. The whole process of search, seizure and label has been made in between 22.45 hrs. to 23.35 hrs on 04.01.24.

Under the above noted fact and circumstances I, pray before your good self that specific case may kindly be initiated against the accused persons namely (i) Tenzing Bhuchung Bhutia (45 yrs) S/O Tenzing Thinlay Bhutia of Tenzing House, T.N. Road, Sonada, Khamahal, PS- Jorebanglow, Dist.- Darjeeling and (ii) Gopen Rai (44 yrs) S/O Deokumar Rai of Thanaline, Daragaon, Sonada, PS- Jorebanglow, Dist. Darjeeling and the owner of CHOZ RESTRO of Salbari, PS- Pradhan Nagar, Dist.- Darjeeling under proper section of law and may arrange to cause its investigation for violation of rules and norms of Bengal Excise Act.
