Sub-Requesting to lodge FIR against Center Manager Mr Avijit Roy, for Misappropriate amount Rs 200955

Respected Sir,

I, Siba Bahadur Rai S/O Hasta Bahadur Rai, residence of Balam Nagar P.O & P.S Bagdogra working as security Manager Delhivery Pvt Ltd situated at the Promod Nagar P.S Bagdogra We would like to file complaint against Operation Manager Mr Avijit Roy residence of Suvashpally Oodlabari which he worked in the Delhivery company Bagdogra since 24 Mar'23(DOJ)

This is because we conducted an audit on 04Jan'24 after receiving complaint from the client end for not delivering the shipments to the customers. We found 27 shipments manually delivered to the customer s but amount Rs 160947 wasn't deposited in the company account. Again he deposited short amount Rs40008 on 4 Jan'23 Total COD amount was Rs 181736 but deposited Rs 141728

Today 05Jan'24, on behalf of company, we asked him regarding short deposition amount Rs 40008 and shipments delivered amount Rs 160947, which he was unable to produce documents. However he confessed that he misappropriate the money of the company dishonestly. In the meantime, Mr Avijit Roy tried to free away from the office, somehow we managed to apprehend him and handover to the police station with the complaint letter and 01 Xerox copy of his misappropriation declaration.

Total Misaappropriate amount Rs 200955 (Rs 40008 +Rs160947) which he is unable to pay

Therefore, I sincerely request you to kindly look into it and file FIR against him
