In producing herewith (06) Six arrested accused persons namely (i) Suraj Chettri (M-20) S/o Lt. Sashti Chettri of Sukanta Pally, Gass Godowan, P.O & P.S. Matigara, Dist. Darjeeling, (ii) Sajal Rai (M-19) S/o Lt. Rupan Rai of Chota Fafri near Radha Krishna Mandir, P.O. Salugara, P.S. Bhaktinagar, Dist. Jalpaiguri, (iii) Sujit Tamang (M-20) S/o Lalit Tamang of Gowala patty, Jhankar More, P.S. Siliguri, Dist. Darjeeling, (iv) Anil Sharma (M-18) S/o Lt. Kumar Sharma of 5th mile, Tadoong Bazar, P.O. Ranipul, P.S. Ranipul, Dist. East Sikkim (v) Chris Limbu (M-22) S/o Lt. Bipin Limbu of Samdur, P.O. & P.S. Ranipul, Dist. East Sikkim, Gangtok and (vi) Anmol Tamang (M-19) S/o Lt. Maniraj Tamang of Kowlay, P.O. Krishna Nagar, P.S. Mirik, Dist. Darjeeling under arrest and the following articles seized articles viz:

- (1) One iron made sword measuring 31 inch (approx.) including wooden butt from the possession of Sujit Tamang which was kept concealed on his back side.
- (2) One iron made sword measuring 34 inch (approx.) including wooden butt from the possession of accd Suraj Chhetri which was kept concealed on his back side,
- (3) One iron made breaking instruments locally called as "PLUS" from the possession of Anmol Tamang.
- (4) One iron made 'Khukri' measuring 17 inch (approx.) from the possession of accd Sajal Rai
- (5) One iron made weapon locally called as "Bhojali" measuring 18 inch (approx.) from the possession of accd Chris Limbu.
- (6) One iron made Sharp cutting steel made knife measuring approx. 8 inches in length seized from the possession of accused Anil Sharma.


I, ASI Biplab Kr. Das of Pradhan Nagar PS, Siliguri Police Commissionerate do hereby lodge this complaint against the above noted 06 (six) arrested accused persons namely (i) Suraj Chettri (M-20) S/o Lt. Sashti Chettri of Sukanta Pally, Gass Godowan, P.O & P.S. Matigara, Dist. Darjeeling, (ii) Sajal Rai (M-19) S/o Lt. Rupan Rai of Chota Fafri near Radha Krishna Mandir, P.O. Salugara, P.S. Bhaktinagar, Dist. Jalpaiguri, (iii) Sujit Tamang (M-20) S/o Lalit Tamang of Gowala patty, Jhankar More, P.S. Siliguri, Dist. Darjeeling, (iv) Anil Sharma (M-18) S/o Lt. Kumar Sharma of 5th mile, Tadoong Bazar, P.O. Ranipul, P.S. Ranipul, Dist. East Sikkim (v) Chris Limbu (M-22) S/o Lt. Bipin Limbu of Samdur, P.O. & P.S. Ranipul, Dist. East Sikkim, Gangtok and (vi) Anmol Tamang (M-19) S/o Lt. Maniraj Tamang of Kowlay, P.O. Krishna Nagar, P.S. Mirik, Dist. Darjeeling and another 05/06 unknown involve accused person to the effect that today on 07.01.2024 at 00.10 hrs received a sources information that 11/12 youths have assembled at Himachal Colony back side of Borough Office with deadly weapons and making preparation for committing dacoity in a house at Himachal colony. Accordingly, I informed the matter to the I/C, Pradhan Nagar PS and diarized the fact in General diary vide Pradhan Nagar PS GDE No 313 dated 07.01.2024. After getting the permission from the I/C, Pradhan Nagar PS myself along with ASI Monoj Kr Roy, C/1411 Ashok Roy, C/1413 Sujit

Sarkar, C/1415 Chandan Basak and C/1416 Dilip Barman all of Pradhan Nagar PS left for Himachal colony,, Back side of Borough Office to verify the veracity of the information. Under this circumstances any search warrant or authorization for search cannot be obtained without affording opportunity for the concealment of evidence or facility for the escape of the offender. On the way I requested night RT van officer SI Md Sahajahan Ali and ASI Mirza Hussain to come at Himachal colony to accompany with us for holding raid at Himachal Colony. At about 00.30 hrs we reached at Himachal Colony near Borough Office and after a few time SI Md Sahajahan Ali along with his van force and ASI Mirza Hussain and his van force arrived at the spot at Himachal Colony near Borough Office and I contact with my source and as pointed by the source we noticed that 11/12 persons were assembled in a dark place and they were whispering in a very low voice. The we cordoned the place very carefully with a strong reason to believe that they were preparing to commit some cognizable offence and started walking towards them. But seeing police personnel approaching towards them they tried to flee away but on hot chase we managed to apprehend above noted five (06) accused persons with deadly weapons in their possession but 05/06 persons managed to fled away from the spot taking the advantage of darkness and open place. On being asked they disclosed their identity as noted above. On interrogation they give different statement in different time and failed to give any satisfactory reply for their presence in the middle of night with deadly weapons. Finally they disclosed that they along with their associates assembled there and making preparation for committing dacoity at Himachal colony area. Accordingly, I seized the above mentioned weapon of offence from their possession under proper seizure list duly signed by the witnesses and acknowledged by the accused persons and subsequently arrested them under proper memo of arrest and observing all the formalities of arrest. I accordingly brought all the six arrested accused persons along with seized article at Pradhan Nagar Police Station for further investigation. During the course of interrogation it could be revealed from the arrested accused persons that they were gathered there and making preparation for committing dacoity in a house of Himachal Colony area. The whole process of search and seizure made in between 00.55 hrs. to 02.05 hrs.

Under the above noted fact and circumstances, I therefore pray before you that a specific case under proper section of Law against may kindly be started against the above noted arrested accused persons namely (i) Suraj Chettri (M-20) S/o Lt. Sashti Chettri of Sukanta Pally, Gass Godowan, P.O & P.S. Matigara, Dist. Darjeeling, (ii) Sajal Rai (M-19) S/o Lt. Rupan Rai of Chota Fafri near Radha Krishna Mandir, P.O. Salugara, P.S. Bhaktinagar, Dist. Jalpaiguri, (iii) Sujit Tamang (M-20) S/o Lalit Tamang of Gowala patty, Jhankar More, P.S. Siliguri, Dist. Darjeeling, (iv) Anil Sharma (M-18) S/o Lt. Kumar Sharma of 5th mile, Tadoong Bazar, P.O. Ranipul, P.S. Ranipul, Dist. East Sikkim (v) Chris Limbu (M-22) S/o Lt. Bipin Limbu of Samdur, P.O. & P.S. Ranipul, Dist. East Sikkim, Gangtok and (vi) Anmol Tamang (M-19) S/o Lt. Maniraj Tamang of Kowlay, P.O. Krishna Nagar, P.S. Mirik, Dist.
