I, SI-Uday Shankar Mandal of Panitanki TOP under Siliguri PS, Siliguri Police Commissionerate do here by lodge this written complaint against above noted 02 (Two) arrested accused persons to the effect that today 06.01.2024 at about 1725 hrs I received a specific source input that two person would be coming to Mahakal Pally behind Suryasen Park, Mahakal Pally, under Siliguri PS, Dist.- Darjeeling with huge quantity of Contraband Drugs for delivering the same to their designed customers. The matter was diarized vide Panitanki TOP GDE No.-128 Dt. 06.01.2024 and I informed the matter to I/C Siliguri PS, Siliguri Police Commissionerate in writing a letter to him and expressed the entire information. As per their kind direction, myself along with other officers and force named ASI Biswajit Ghosh, C/114 Naresh Hajda, C/984 Subashish Das all of Panitanki TOP, under Siliguri PS, Siliguri Police Commissionerate being headed by me left for Mahakalpally, behind Surya Sen Park, Ward No.- 10, PS- Siliguri, Dist.- Darjeeling by govt. vehicle with investigation kit to verify the veracity of the information in hand vide Panitanki TOP GDE No 129 dated 06.01.2024 and M.C.C. No. 25/24 dated 06.01.2024. In the meantime I also informed the Videographer namely Somnath Chatterjee (39) so SushilChaterjee of Gokhel Road, Ward No.- 22,PO-Rabindra Nagar, PS-Siliguri, Dist.- Darjeeling to be present at Mahakalpally, behind Surya Sen Park to prepare the Video of whole process of search and seizure if any as well as informed Mobile Van officer namely ASI Surajit Mallik who is detailed for Mobile Van vide Panitanki TOP MCC No.- 23/24 date: 06.01.2024 to accompany us during the whole process of search and seizure if any. Under these circumstances any search warrant or authorization cannot be obtained without affording opportunity for the concealment of evidence of facility for the escape of the offenders. At about 1805hrs we arrived at Mahakalally, behind Surya Sen Park, Mahananda river Bed, Ward No.- 10, PS- Siliguri, Dist.- Darjeeling and on the way to the spot at Suryasen Park, I called two independent witnesses namely i) Subhod Kr. Mahato (23) s/o Sri Lal Babu Mahato of Iskon Mandir, Durga Nagar, Ward No.- 40, PS- Bhaktinagar, Dist.- Jalpaiguri (ii) Dipankar Dur (30) s/o Lt. Arun Das of Dashrath Pally, Ward No.- 44, PS- Bhaktinagar, Dist.- Jalpaiguri and disclosed our identity and informed them about the information in hand and requested them to accompany us and remain present in the whole process during search and seizure if any. Accordingly I, served Notice with a written letter and necessary permission of their presence and act as witnesses under relevant provision of law. After arrival at the spot and as identified by the source we found that 02 (Two) persons were waiting for someone at Scotty at Mahakalally, behind Surya Sen Park, Mahananda river Bed which was matched with our information. Accordingly, we intercepted the scotty and apprehended two who disclosed his identity as noted above.

After disclosing our identity, we detained the above noted persons with a strong reason to believe that After disclosing our lucinity, we detailed in their joint possession which they carrying in their scotty they illegally possessing Contraband Drugs in their joint possession which they carrying in their scotty they illegally possessing collidation by Koushik Saha as Pilon raider for selling the same to their designed reading by Monaj Roy (43) and assist by Koushik Saha as Pilon raider for selling the same to their designed reading by Monaj Ruy (43) and assist of Rodamic defined they confessed that they possessed contraband drugs in customers for their wrongful gain. On being asked they confessed that they possessed contraband drugs in customers for their wronging game of them an option in writing whether they wanted to be searched in presence their joint possession. I then gave them an option in writing whether they wanted to be searched in presence of an Executive Magistrate or by any Police Gazetted Officer. Then they agreed to be searched by any one of them. Further, I served them notice in accordance with provisions of law in this regard. I also offered the independent witnesses and the two apprehended persons to search our Police Party as per provision of law but they refused to search the police party. Accordingly, I informed the matter to the Officer-In-Charge, Panitanki TOP, under Siliguri PS, SPC as well as I/C, Siliguri PS, SPC and as per their kind order I informed the fact to Sri Santanu Tarafdar, WBPS, Assistant Commissioner of Police, AP, Siliguri Police Commissionerate detailed for acting as Special Executive Magistrate, of SPC as per order of superior [detailed Special executive Magistrate were busy on other government duty] regarding the interception of the accused persons suspected to be possessed of Contraband Drug in their scotty raiding by them and requested him to come to the spot and to supervise the search and seizure being a gazette officer. Accordingly at 2045 hrs Sri Santanu Tarafdar, WBPS, Assistant Commissioner of Police, AP, Siliguri Police Commissionerate arrived at the spot and accordingly, I disclosed his identity to the detained persons as Special Executive Magistrate of Siliguri Police Commissionerate.

Then in presence of Sri Santanu Tarafdar, WBPS, Assistant Commissioner of Police, AP, Siliguri Police Commissionerate detailed as Special Executive Magistrate and two independent public witnesses searched the detained persons following all formalities but nothing could be recovered from their body except wearing apparel and subsequently I, searched the scotty bearing registration No.- WB74/BJ/5961 in presence of Executive Magistrate Shri Santanu Tarafdar, WBPS, Assistant Commissioner of Police, AP, Siliguri Police Commissionerate and recovered (i) 20 (Twenty) bottles of Triprolidine Hydrochloride and Codeine Phosphate Syrup styled as "BESCODEX" each bottle containing 100 ml in each bottle M.R.P. Rs.- 190/- (One Hundred Ninety) marked as Exhibit "A" (ii) 40 (Forty) vials of Diazepam Injection IP Style as NRX contain 2ml in each bottle @ Rupees 15 marked as Exhibit-"B" (iii) 40 (Forty) vials of Buprenorphine Injection IP style as LUPIGESIC contain 2ml in each bottle @ Rupees 17.60 Marked as Exhibit "C". (iv) 40 (Forty) vials of Promethazine Hydrochloride Injection IP style as PHENERGAN contain 2ml in each bottle @ Rupees 12.19. Marked as Exhibit "D" which is kept in white color carry bag style as "NEW BISWA ARUPA below the scotty seat's vacant place bearing registration No.- WB74/BJ/5961. On demand in presence of the Executive Magistrate Shri Santanu Tarafdar, WBPS, Assistant Commissioner of Police, AP, Siliguri Police Commissionerate they failed to produce any valid document in support of joint possessing of Contraband Drugs which they carried in the scotty as well as failed to produce any valid documents of scotty bearing registration No.- WB74/BJ/5961.

Thereafter, in presence of Sri Santanu Tarafdar, WBPS, Assistant Commissioner of Police, AP, Siliguri Police Commissionerate and independent witnesses I took out the following samples (i) 02 (Two) bottles of Triprolidine Hydrochloride and Codeine Phosphate Syrup styled as "BESCODEX" each bottle containing 100 ml in each bottle M.R.P. Rs.- 190/- (One Hundred Ninety) taken out from Exhibit "A" marked as Exhibit-"A1". And (ii) 09 (Nine) vials of (i) Diazepam Injection IP (ii) Buprenorphine Injection IP (iii) Promethazine Hydrochloride Injection IP taken out from Exhibit "B", "C" & "D" [03 vials each from Exhibit "B", "C" & "D"] marked as exhibit-"D1". Further, on demand in presence of Sri Santanu Tarafdar, WBPS, Assistant Commissioner of Police, AP, Siliguri Police Commissionerate detailed for acting as Special Executive Magistrate, of SPC for the day as well as independent witnesses the above noted detained persons failed to produce any valid documents in support of joint possessing of contraband Drugs. Thus when their involvement in carrying and possessing Contraband Drugs was established, then I seized the above noted articles from the exclusive joint possession of the above noted accused persons at the spot at Mahakalally, behind Surya Sen Park, Mahananda river Bed, Ward No.- 10, PS- Siliguri, Dist.- Darjeeling under proper seizure list in presence of Executive Magistrate Sri Santanu Tarafdar, WBPS, Assistant Commissioner of Police, AP, Siliguri Police Commissionerate detailed for acting as Special Executive Magistrate, of SPC for the day as well as independent witnesses as noted above and acknowledged by the accused persons. Subsequently, I labelled the seized articles in presence of Sri Santanu Tarafdar, WBPS, Assistant Commissioner of Police, AP, Siliguri Police Commissionerate and independent witnesses and accused persons as noted above. The whole process of seizure was made in between 2055 hrs to 2155 hrs on 06.01.2024. On further asked they confessed in presence of Sri Santanu Tarafdar, WBPS, Assistant Commissioner of Police, AP, Siliguri Police Commissionerate acting as Special Executive Magistrate and other witnesses that they procured the Contraband Drugs clandestinely from Malda for the purpose of supply the same to their designed customers at Siliguri area as per their requirement for their personal gain by illegal means. On interrogation they also disclosed that they have been dealing in such business of selling Contraband Drugs illegally for the last few months.
