When my girl raised her voice all the accused came out of their house and attacked my daughter, when I heard the voice of my daughter I came out from my house and tried to save my girl from their clutches and during that time I sustained several minor injuries on that time. That Mira Sahani accused no.1 snatched my gold mangal sutra from my neck and one silver chain from my daughter's neck, that they also snatched Rs.10,000/- from my house which was earned by my husband yesterday.
