
I, SI Agen Lepcha of Pradhan Nagar PS, SPC do hereby lodge this complaint against accused Hiramohan Saha S/O Late Tileswar Saha of Bagha Jatin Colony, near Mukta Mancha, Ward No-02, PS- Pradhan Nagar, Dist.- Darjeeling to the effect that today i.e. on 08.01.24 at 16.05 hrs I received a specific source information that one person namely Hiramohan Saha of Bagha Jatin Colony near Mukta Mancha under PS- Pradhan Nagar, Dist.- Darjeeling stored huge numbers of illegal gas cylinder at his grocery shop without any valid documents. Accordingly, the matter was diarized in General Diary vide Pradhan Nagar PS GDE No 399 Dt. 08.01.24 and informed the fact to the Inspector-In-Charge, Pradhan Nagar PS who directed me to verify the veracity of the information. Accordingly, myself along with SI Bandhan Roy, SI Bijoy Sarkar and force left for Bagha Jatin Colony near Mukta Mancha under PS- Pradhan Nagar, Dist.- Darjeeling to verify the veracity of the information in hand. Under this circumstance any search warrant or authorization cannot be obtained without affording opportunity for the concealment of evidence or facility for the escape of the offender. On the way to the spot I shared the information to all the officers and force accompanied with me and briefed them properly. At around 16.25 hrs we arrived at Bagha Jatin Colony near Mukta Mancha and I contacted with my source I held raid in a grocery shop but seeing the police party proceeding toward his shop he managed to fled away from the shop. Then, in presence of the independent witnesses, searched was conducted and found total 08 (eight) numbers of domestic gas cylinders mentioned above which was kept inside his shop. During enquiry in presence of local witnesses it could be revealed that one Hiramohan Saha S/O Late Tileswar Saha of Bagha Jatin Colony, near Mukta Mancha, Ward No-02, PS- Pradhan Nagar, Dist.- Darjeeling illegally procured the said gas cylinders an essential commodity and combustible in nature, clandestinely and stored the same, without any precautionary and safety measures, for selling the same with increasing rate for his wrongful gain but during police raid he managed to fled away from the spot.

From the above facts, it is evident that the above noted person is involved in procuring of Gas Cylinder in fraudulent means and kept the same in his shop without any precautionary and safety measures which is combustible in nature and endanger to human life and property. Subsequently, he used to sell the same in increased rate to his designed customers for his wrongful gain, contravening the norms of Essential Commodity Act, 1955. Accordingly, I seized the following gas cylinders under proper seizure list in presence of witnesses and subsequently labeled the same. The whole process of seizure was made in between 17.25 hrs to 18.35 hrs.

- (i) 03 (three) numbers of loaded Indane domestic Gas Cylinder.
- (ii) 02 (two) numbers of empty Indane domestic Gas Cylinder.
- (iii) 02 (two) numbers of loaded HP domestic Gas Cylinder.
- (iv) 01 (one) empty HP domestic Gas Cylinder.

Under the above circumstances, I pray to you that a specific case under proper section of law may kindly be started against the accused person namely Hiramohan Saha S/O Late Tileswar Saha of Bagha Jatin Colony, near Mukta Mancha, Ward No-02, PS- Pradhan Nagar, Dist.- Darjeeling and arrange for its investigation.
