Sir,

I, Mohammad Habibar Rahman, S/o Late Badiojaman, resident of Damra Gram, Udaysingh, Salbari, under P.S. Pradhan Nagar, Dist. Darjeeling, would like to inform you and report you the following:

That my father Badiojaman (now deceased) S/o Nabab Uddin, during his lifetime had become the absolute owner in possession of all that 0.85 Acre of land in R.S. Plot Nos. 56, 57, 58, 59, 69 & 70, within Mouza Mahatram, Pargana Patharghata, J.L. No.50, Touzi No.91, under P.S. Siliguri (now Pradhan Nagar), Dist. Darjeeling, by virtue of purchase from one Abdul Gafur, S/o Late Najiruddin, through a Deed of Sale being document No. I- 4697 for the year 1980 registered at the office of the Sub-Registrar, Siliguri dated 21.08.1980.

That subsequently the said entire 0.85 Acre of land was recorded in the name of my said father Badiojaman Mohammad in L.R. Khatian No.21, comprising L.R. Plot Nos. 31 (area measuring 0.56 Acre) and 75 (area measuring 0.29 Acre), within Mouza Mahatram, J.L. No.50, under P.S. Siliguri (now Pradhan Nagar), Dist. Darjeeling, and since the date of purchase my said father till his death was in physical possession of the said entire land and after his demise I myself along with other legal heirs are in absolute possession of the said landed property.

But today morning at around 9.00 am (1) Begum, W/o Abdul Gafur, (2) Saheda Khtun, D/o Late Abdul Gafur, (3) Makbul Hossain @ Mukul Hossain, S/o Late Basiruddin Md., & (4) Rajen Goala, S/o Late Suku Goala, all are residents of Damra Gram, Salbari, forcefully made attempt to illegally make encroachment in our aforesaid 0.29 Acre of land in L.R. Plot No.75, within Mouza Mahatram, J.L. No.50, under P.S. Siliguri (now Pradhan Nagar), Dist. Darjeeling by installing some concrete pole in and over our part of land. But then and there I immediately restrained them in doing so and compelled them to leave the place but still they are openly declaring that they will any how grab and occupy the said land from us.

That in view of aforesaid circumstances I, hereby request you to look into the matter and also to take immediate and appropriate steps against the said wrongdoers as per provisions of law.
