I, SI Samik Paul of New Jalpaiguri Police station, Siliguri Police Commissionerate do here by lodge this written complaint against above noted two (02) arrested accused persons to the effect that today 06.01.2024 at about 16.35 hrs I received a specific source input that two persons were coming from Medical more towards Naukaghat with huge quantity of Contraband Drugs (injection) for delivering the same to their designed customers. The matter was diarized vide NJP PS PS GDE No. 239 Dt. 06.01.2024 and I informed the matter to SI Partha Sarathi Das, Officer-In-Charge, New Jalpaiguri Police Station in writing a letter to him and expressed the entire information. As per his kind direction myself along with other officers and force named ASI Khagen Barman, C/453 Uttam Dey, C/152 Abdul Kayum Mia, VP/13 Jamirul Islam, all of NJP PS, Siliguri Police Commissionerate being headed by me left for Viswa Bangla Shilpi hat by govt. vehicle with investigation kit to verify the veracity of the information in hand vide NJP PS GDE No 239 dated 06.01.2024 and M.C.C. No. 43/24 dated 06.01.2024. In the mean time I also informed the Videographer namely Tapan Mandal s/o Testo Mandal of Bhola More, PS- NJP, Dist.- Jalpaiguri to be present near Viswa Bangla Shilpi hat to prepare the Video of whole process of search and seizure if any as well as informed Mobile Van officer who is detailed for Mobile Van vide New Jalpaiguri PS MCC No.- 3/24 date: 06.01.2024 namely ASI Nilam Swarnakar to accompany us during the whole process of search and seizure if any. Under this circumstances any search warrant or authorization cannot be obtained without affording opportunity for the concealment of evidences of facility for the escape of the offender. At about 17.05 hrs we arrived near Viswa Bangla Shilpi hat, and on the way to the spot I called two independent witnesses namely (i) Kartik Mandal s/o Lt. Falguni Mandal of Porajhar, PS NJP, Dist.
