I, AMIT GOYAL, Son of Late Ramlaxman Goyal of Satya Sen Road, Madhurika Apartment, Flat no. 4A, P.S. & P.O. Siliguri, Pin – 734001 would like to lodge an FIR against Abhinay Goyal, son of Sri Ajay Goyal and Smt. Anita Goyal, Resident of M.B. Residency, Sukanta Sarani Road, East Milan Pally, P.S. & P.O. Siliguri, Dist-Darjeeling, Pin – 734005 in regards to cheating by breaching my trust, misappropriation, and criminal intimidation against ABHINAY GOYAL.

That on 17th of October 2023, Abhinay Goyal, son of Sri Ajay Goyal and Smt. Anita Goyal, Resident of M.B. Residency, Sukanta Sarani Road, East Milan Pally, P.S. & P.O. Siliguri, Dist-Darjeeling, Pin – 734005 called me and informed me that he was in urgent need of money for his personal and family issues.

That I asked him random questions to which he said that if I did not pay him he would not be able to face the world anymore. He completely manipulated me to pay him the amount that he desired.

That he came to my home and tried to convince me and when I agreed to pay, he told me to transfer the amount within the night.

That soon immediately after arranging the money I transferred him a total of 95,000/- only within the 17and 18th of October, 2023 through Google Pay.

The payments are as follows:

- a. On 17th of October, 2023
 - at around 9:38 pm = Rs 50,000/-
 - at around 9:50 pm = Rs 1000/-
 - at around 9:52 pm = Rs 3000/-
 - at around 9:53 pm = Rs 6000/-
 - at around 9:54 pm = Rs 2000/-
- b. On 18th of October, 2023
 - at around 9:04 pm = Rs 30,000/-
 - at around 9:08 pm = Rs 3,000/-

That I paid him 45,000/- from my client's phone pay account namely Sri. Sunil Agarwal, due to his dire need on the 7th of November, 2023. He assured me to pay back the entire amount of rupees 1,40,000/- only within 20th November, 2023 but he has not, and neither has he called me, in fact when I called him several times, he did not receive my call and later I came to know that he had absconded from his residence, when I inquired about him I came to know that he had been residing at Kolkata, West Bengal. In regards to that, he even changed his phone number due to which I was unable to contact him, and after a considerable period of time he came back to Siliguri with his maternal uncle. knowing this when I visited his home and came to know that he cheated many persons in this habitual manner, there are many other persons from whom he has taken various amounts of money and never contacted or returned their amounts pending, in fact his parents had assured me in the presence of his maternal uncle, that even if he failed to pay, his parents would return the amount

outstanding of Rs.1,40,000/- within 25 days. But after the elapse of all this while when I called him, he did not receive the call and later when I tried to contact him, he blocked my phone number thereafter I called him from another number to which his mother picked up the call and started to threaten me that if I ever called him then I shall be beaten up by the local goons who are well-versed to them and also threatened me that if I try to lodge complain before any Police Station then he will teach me a good lesson as he has good connections with the higher police officials and political influential persons so that no one can cause him any harm.

legal notice to Thereafter through my lawyer, I served him a return the arrear amounts ie., the amount of 1,40,000/-(Rupees One lakh Forty thousand only) within 15 days. After which he received the notice but did not answer. On 04/01/2024 when I his mother's mobile number his insistently called completely refused to pay the entire amount even though he and his parents are liable to pay me the outstanding amounts which he had taken from me by manipulating my maternal relation with me. Using the same he cheated me by breaching my trust, with dishonest intentions he misappropriation me for wrongful gain in a habitual manner and intimidated me, insulted my reputation with an intention to cause harm, not only this he has threatened me to cause harm to my life through his political and influential connections.

That finding no other alternative I kindly request you to register this F.I.R and initiate a case against the above-named alleged person under appropriate sections for the earnest means of justice
