SUB:- LODGING OF FIR

On dtd 08.01.24, on a specific source information regarding movement of 01 truck carrying cattle heads without valid documents going to Meghalaya and further smuggling to Bangladesh. On getting such information special joint operation has been planned in direction of FGT SLG by Sh Shalinder Singh, AC, Coy comdr of BOP Fulbari ex 176 BN BSF along with 01 So, 03 Ors (Including Unit G cell) and FGT SLG along with ASI A B Das and 03 Ors of NJP Police station, as per planning at around 082230 hrs, the special ambush was laid on NH 31, appx 500 mtr away from Fulbari Toll Plaza towards Goshpukur. At around 082310 hrs party observed movement of suspected Truck was coming from Mahananda Barrage side NH 31 bearing registration no NL01L0531 which was provided by the source. At around 2315 hrs the Truck was intercepted by the ambush party near Fulbari Toll Plaza. The Party asked driver to produce documents but no documents pertaining to truck and buffalos were produced by the driver of vehicle. The buffalos are badly stuffed in side the truck and many of them injured due to scramble and lack of space. On counting it was revealed that there where 43 nos buffalos inside the truck. Accordingly 01 truck bearing No. NL01L0531 and 43 nos Buffalos were seized by the party and 01 driver and 03 person were apprehended. The details are as under:-
