Respected Sir,

I **SRI UJJAL MANDAL**, son of Late Mahadeb Mandal, resident of Village - Narayan Pally, Police Station - Matigara, District - Darjeeling, beg to state that one **Mithila Barman**, daughter of Niren Barman, permanent resident of Rangia, Police Station - Matigara, District - Darjeeling & presently resident of Indira Pally, Shivmandir, P.O. Kadamtala, P.S. Matigara, Dist- Darjeeling, was filed a criminal case against me before Matigara Police Station on the basis of the said complain one specific case was registered by Matigara Police Station being Matigara PS case No- 600/18 dated 17/11/18 and on the basis of the said Complain on very next date police was arrested me and sent me to the judicial custody, from where I had been behind the bar for 17 days before I enlarged on bail and thereafter police filed the charge sheet against me in the instant case matter under section 417/376 of IPC and thus as a law abiding citizen I have been facing trial before the Ld F.T.C Court at Siliguri each and every date as per the direction of the Ld F.T.C court.

But on the last occasion on 21/12/23 the above said Mithila Barman (defecto complainant of the aforesaid case) was appeared before the Ld F.T.C court at Siliguri for giving her evidence in the said instant case vide **Matigara P.S. Case No- 600/18 corresponding to Session Case No. 67/22**, and after finishing her evidence she was become very aggressive as she had realised that her false allegation would not stand before the eye of Law and as such she started threatening me through mobile and also from different site of the social media for dire consequence by filing another false case against me but I kept my self calm.

In the mean time said **MITHILA BARMAN** demanded ransom amount of money by adding repeated threat that, she would kill herself by taking poisons. As such before we could have found legal solution, on 24-12-2023 at about 3:30 A.M, the accused namely **MITHILA BARMAN** along some people came inside illegally at my house and started banging the door of my house so hardly and forcefully as a result all members of my house become so nervous and frightful and after that finding no alternative I had to open the door and after opening the door they pushed me so hard that I fall down on the floor of my room as a result I suffered heavy injury on my hand. During this time the accused persons were constantly demanding ransom cash money Rs. 2,00,000/- (Rupees Two Lacs) only on the spot but I told them that I had no money in my house as a result the accused namely **MITHILA BARMAN** was being started to black mailing me by showing gesture of hanging to kill herself, in the mean time I informed to the Matigara police through my mobile No. 6296662913 at about 4:22 A.M, in the mid of such incident, people were started to notice the fact from outside, seeing that matter could go outside of their (accused) hands, all accused person except the main culprit Namely **MITHILA BARMAN**, escaped from the spot by keeping demand of ransom money after that police came to the spot and control the situation. As a result of such incident I am going through under Medical Supervision of N.B.M.College & hospital and still I cannot able to move my hand freely.

It is a pertinent to mention the fact I have been going through under medical supervision and treatment as a result I could not submit this complain immediately before you after the above said incident took place, but the said incident was informed by me before Siliguri Police commissioner in a immediate manner for taking necessary action.

Under such circumstance and from above said facts it is crystal clear that the above said accused person neither have any regard of law nor having respect of Judicial process, otherwise they could not commit above said criminal act. Therefore it is being requested you to take immediate steps to prevent the accused persons to commit any such illegal Act against me and my family members as because I along my family members are the under the constant threats of the accused persons, so anything can happen at any time if necessary steps are not taken in time from your side.
