**Sub: Complaint against intentionally hit to scooty rider by offending vehicle TUV
300 bearing reg. no. WB A 2772**

Sir,

I, the undersigned would like to inform you that on 05.01.2024 at about 11.00 pm I and my sister Pratima Rai, D/o Durga Prasad Rai was going to home at Dhukuria Jote, Patherghatta, P.s Matigara after completion of music audition fest from Siliguri town by scooty, one motor vehicle TUV 300 bearing registration no. WB 77 A 2772, silver in colour had come intentionally from right side of the road divider in front of SIMS Hospital, Panchanai rail crossing, Dagapur and hit my scooty bearing registration no. WB 74 BQ 3086 with intends to cause death. I was unconscious for 2/3 mints, subsequently I and sister received internal body and head injury and the scooty and mobile was damaged very badly, immediately local shopkeeper gathered at spot and called Pradhan Police van and took my scooty to P.S, but the offending vehicle fled away after seeing the Police person and the local people informed to guardian and they took us for medical treatment at Mohapal Nursing Home, Pradhan Nagar and advice for Neuro specialist. On being asked he disclosed his identity as Munindra Lama of Pradhan Nagar, Siliguri. And the doctor advice for totally bed rest for 1 week, hence today I am lodging this FIR against the said Munindra Lama.

The said accident was occurred intentionally of the driver of said offending vehicle to cause death of me and sister and he was fully intoxicated.

Therefore, I request to you kindly take a legal action against the said offending motor vehicle, and I shall be grateful for your kind co-operation.
