**SUB:** - Written Complaint against my husband **1. Md. Chand Hussain, 2. Smt. Julekha Begum [Mother-In-Law] 3. Smt. Saizaidi Khatoon [Sister-In-Law]**, all are residing at Chapra, Khairabhatti, P.O. & P.S., Khairabhatti, Dist.: - Chapra, Bihar.

Sir,

With due respect I Smt. Noorie Khatoon, W/o Md. Chand Hussain, D/o Sk Abdullah, presently residing at my parental house at Ashraf Nagar, P.O. Hyderpara, P.S. Bhakti Nagar, Dist.: - Jalpaiguri-734006, would like to draw your kind attention towards the following effect that on 28.09.2023 our marriage was solemnized at Serishthapur, Mehenditola, Janta Bazaar, Bihar according to Muslims Rituals. That before the date of marriage fixed the aforesaid above-named persons took huge amount of dowry amounting Rs. 1,40,000/- [One Lakh Forty Thousand Only] and my old age ailing father transferred Rs. 50,000/- [Fifty Thousand Only] transferred in the A/C of **Smt. Julekha Begum [Mother-In-Law]** and rest Rs. 90,000/- [Ninety Thousand Only] cash was handover in the hands of Julekha Begum in cash from my said parental residence as above mentioned i.e., Ashraf Nagar.

Thereafter date was fixed and at the time of marriage my father also gave Gold Ornaments amounting Rs. 4,50,000/- [Four lakh Fifty Thousand Only] containing one gold necklace, 2 pair of gold ear rings, one gold nose pin, two gold finger rings, one gold mangtika and also gave silver ornaments, garments, utensils, furniture and all essentials household items in order to start a new marital life as per their demands.

But after inception in my matrimonial house, they used to start taunting me that Stree-Dhan Properties are not up to the mark "BHIKARI KAH BACCHA" and also demanded Rs. 2,00,000/- [Two Lakh Only] more from my father but I denied for which the aforesaid persons above named mercilessly beaten me on 20.12.2023 for which I sustained severe head pain & also body ache, actually their intention was to kill me and my husband tried to strangulate me with my dupatta for which I sustained huge neck pain, at that time I contacted my father over cell phone in whipping condition and told him the incident but at that time my husband snatched my cell phone.

My father and my sister husband [Jamai] named AJMAYTULLAH came to my matrimonial home at around 04:30 P.M on 22.12.2023 but there also the aforesaid above-named persons misbehaved with my father and with my

sister's husband hurling them with filthy languages and subsequently within no time they drove me, my father and my sister's husband from the matrimonial house premises in a single piece of cloth. Somehow my father and sister's husband took me in our another village in Bihar and wherein my treatment was going on but my health condition is detorting day by day for which my father took me to another doctor on 30.12.2023 and after being stable on 02.01.2024 I came back with my father at my parental house. It is to be noted that my mother-in-law has taken the custody of my all Gold and Silver Ornaments, and my husband has snatched my Cell phone brand: - VIVO, being contact No: 7029763834 and my husband threatened me by saying that he will viral my nude photos by editing my face with some revealing posture to maline me through my cell phone so as to I will be forced to commit suicide if such pictures come before the society.

Since than I am residing there in a precarious condition and suffering from anxiety, insomnia etc. That some unintentional delays have occurred to inform this matter as because the heath condition of me was not at all stable and I was both physically and mentally weak and traumatised from the said incident.

Therefore, you are requested to look into the matter and take proper legal action / steps against the above-named persons as per law.
