
I, SI. Biswajit Adhikari of Bhorer Alo PS, SPC, do hereby lodge a written complaint against (i) Sujit Dey S/O Lt. Harimohon Dey Of 2 No. Takimari, PS-Bhorer Alo, Dist-Jalpaiguri, (ii) Anukul Gain S/O Kiran Gain of DO, (iii) Dhanesh Barman S/O Lt. Basudeb Barman of Maharajghat, PS-Bhorer Alo, Dist-Jalpaiguri, (iv) Uttam Das S/O Khirmohan Das of 2 No. Takimari, PS-Bhorer Alo, Dist-Jalpaiguri & 50-60 others accused persons to the effect that on 28.12.2023 around 10.05 hrs I got information from the duty officer ASI Pranab Das of Bhorer Alo PS that a huge number of supporters of Bharatiya Janata Party (BJP), Takimari branch blockade the road at Takimari Bazar More. This refers to Bhorer Alo PS GDE No. 284 dt. 28.12.2023. Accordingly I along with force rushed to the spot to verify the veracity of information. On arrival at about 10.25 hrs at Takimari Bazar I found that the supporters of BJP party numbering about 50/60 persons blockade the main road at the triangle junction of Takimari Bazar, causing obstruction the vehicular traffic at the traffic point from all directions. As a result vehicular movement totally stopped and the same caused inconvenience to the public. The mob was showing protest over the issue of arrest and punishment to the culprit who committed rape upon a girl at Takimari area under Bhorer Alo PS. Accordingly I informed the matter to O/C, Bhorer Alo PS, SPC for sending sufficient force and officers. At about 10.45 hrs O/C, Bhorer Alo PS along with other officers & force arrived to the spot. The agitators were asked to leave the road immediately as their act was causing obstruction in public road by their unlawful assembly and they had no prior permission for conducting such road blockade in this area. But the agitators did not pay heed to our words and they continued the obstruction for approx one hour. Over their unlawful activity school students, Ambulance, passenger Vehicles, State Bus, Truck etc were stuck there for one hour. At last we intervene the matter and dispersed the mob and make the situation normal.

Hence, I request you to kindly start a specific case against (i) Sujit Dey S/O Lt. Harimohon Dey Of 2 No. Takimari, PS-Bhorer Alo, Dist-Jalpaiguri, (ii) Anukul Gain S/O Kiran Gain of DO, (iii) Dhanesh Barman S/O Lt. Basudeb Barman of Maharajghat, PS-Bhorer Alo, Dist-Jalpaiguri, (iv) Uttam Das S/O Khirmohan Das of 2 No. Takimari, PS-Bhorer Alo, Dist-Jalpaiguri & 50-60 others accused persons under proper section of Law and arrange for investigation.
