Dear Sir,

With due respect, I the undersigned beg to state that I got married with Sri Nikesh Golyan, Son of Late Rohit Golyan, resident of Shyamantak Apartment, 04<sup>th</sup> Floor, Himachal Sarani, Hyderpara, Siliguri, West Bengal, PIN- 734001 on 10/02/2008 at Siliguri.

After marriage I always tried to make understand my husband that I am his legally married wife and I always tried to give my love and affection to my husband and in laws by performing my duties towards them as a wife of my husband so that my marital days may pass peacefully. But contrarily, my husband always tried to avoid me as if I am not the legally married wife of my husband and always treated me with cruelty and abused me in filthy languages.

In the meantime, a daughter namely "Jeevika Golyan" was born on 11.06.2009 and son namely "Piyush Golyan" was born on 11.06.2015 to me due to my said wedlock and I had/have been leading my life seeing the faces of my children with an hope that good sense would prevail to my husband and my marital life would become joyful in due course of time. But good sense has not prevailed upon my husband.

My husband always used to insult my family members including my mother, brother and sister and also defame my brother Sri Ashish Agarwal in the society. My husband used to link up and used to say that I have an affair with my own younger brother Sri Ashish Agarwal and always labeled false and dirty allegations against me.

My husband has/had several times threaten to kill me and my family members and used to say that he has/had hired goons to do so and if I report this to anyone I have to face the consequences thereof.

That my husband always used to assault me without having any reasons and his mental and physical torture have started to increase day by day. The habit of my husband to drink liquor/alcohol and visiting Singing Bar has gradually become excessive and in course of his intoxicated state of affairs, he used to cause excessive physical and mental torture and created the vulgar/obscene not only before/upon me but also in presence of other family members including in presence of my children threaten me to drove out from my home.

That on 11.01.2024, my husband came to home in a drunken condition and assaulted me without having any reasons tortured me mentally and physically and beaten me. That my husband in drunken condition called my brother namely Sri Ashish Agarwal over mobile phone and said him to come to home and take me along with my children from his house. And accordingly my brother Sri Ashish Agarwal tried to reconcile the matter but to no and good and ultimately on 12.01.2024 my brother along with my mother to save my life any how managed to escape from there. Had I not taken the shelter at the house of my parents at the said time, my husband would have finished my life. That when my brother Sri Ashish Agarwal came to my

marital home to take me and my Children than my husband hit my brother with fists and blows and threaten with dire consequences.

So, I request you Sir, to be kind enough to investigate into the matter and arrange to punish the culprits by doing the needful into the matter.
