With due respect and humble submission I ASI. (UB) 1173 Haripada Roy of Bhaktinagar Traffic Guard/SPC beg to state that on 14.01.2024 at 23.15hrs, while performing RTA night duty at Bhaktinagar Traffic guard found that one truck bearing registration No. RJ27GE4221, rashly run over a male person at Try Junction under Bhaktinagar Police Station. As a result the person received severe injury and shifted him to Siliguri District Hospital where attending doctor declared him as dead. Subsequently I tried to identify the address of the victim but in vain.

Therefore, I pray before you that a specific case may kindly be initiate in this regard and cause its investigation.
